## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Disabled Law Enforcement Officers and Rescue Workers – Property Tax**  
3 **Credit**

4 FOR the purpose of authorizing the Mayor and City Council of Baltimore City or the  
5 governing body of a county or of a municipal corporation to grant a certain  
6 property tax credit for certain residential real property owned by certain  
7 disabled law enforcement officers and rescue workers; defining a certain term;  
8 altering ~~a certain definition~~ certain definitions; providing for the application of  
9 this Act; and generally relating to a property tax credit for certain residential  
10 real property owned by certain disabled law enforcement officers and rescue  
11 workers.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Tax – Property**

20 9–210.

21 (a) (1) In this section the following words have the meanings indicated.

1           **(2) “DISABLED LAW ENFORCEMENT OFFICER OR RESCUE**  
2 **WORKER” MEANS AN INDIVIDUAL WHO:**

3                   **(I) HAS BEEN FOUND TO BE PERMANENTLY AND TOTALLY**  
4 **DISABLED BY AN ADMINISTRATIVE BODY OR COURT OF COMPETENT**  
5 **JURISDICTION AUTHORIZED TO MAKE SUCH A DETERMINATION; AND**

6                   **(II) BECAME DISABLED:**

7                           **1. AS A RESULT OF OR IN THE COURSE OF**  
8 **EMPLOYMENT AS A LAW ENFORCEMENT OFFICER OR A CORRECTIONAL**  
9 **OFFICER; OR**

10                           **2. WHILE IN THE ACTIVE SERVICE OF A FIRE,**  
11 **RESCUE, OR EMERGENCY MEDICAL SERVICE, UNLESS THE DISABILITY WAS THE**  
12 **RESULT OF THE INDIVIDUAL’S OWN WILLFUL MISCONDUCT OR ABUSE OF**  
13 **ALCOHOL OR DRUGS.**

14                   **[(2)] (3) (i) “Dwelling” means real property that:**

15                           1. is the legal residence of a **DISABLED LAW**  
16 **ENFORCEMENT OFFICER OR RESCUE WORKER OR A** surviving spouse; and

17                           2. is occupied by not more than two families.

18                           (ii) “Dwelling” includes the lot or curtilage and structures  
19 necessary to use the real property as a residence.

20                   **[(3)] (4) “Fallen law enforcement officer or rescue worker” means an**  
21 **individual who dies:**

22                           (i) as a result of or in the course of employment as a law  
23 **enforcement officer OR A CORRECTIONAL OFFICER; or**

24                           (ii) while in the active service of a fire, rescue, or emergency  
25 **medical service, unless the death was the result of the individual’s own willful**  
26 **misconduct or abuse of alcohol or drugs.**

27                   **[(4)] (5) “Surviving spouse” means a surviving spouse, who has not**  
28 **remarried, of a fallen law enforcement officer or rescue worker.**

29                   (b) The Mayor and City Council of Baltimore City or the governing body of a  
30 county or municipal corporation may grant, by law, a property tax credit under this  
31 section against the county or municipal corporation property tax imposed on a

1 dwelling that is owned by a **DISABLED LAW ENFORCEMENT OFFICER OR RESCUE**  
2 **WORKER OR A** surviving spouse of a fallen law enforcement officer or rescue worker:

3 (1) if the dwelling was owned **BY THE DISABLED LAW**  
4 **ENFORCEMENT OFFICER OR RESCUE WORKER AT THE TIME THE LAW**  
5 **ENFORCEMENT OFFICER OR RESCUE WORKER WAS ADJUDGED TO BE**  
6 **PERMANENTLY AND TOTALLY DISABLED OR** by the fallen law enforcement officer or  
7 rescue worker at the time of the fallen law enforcement officer's or rescue worker's  
8 death;

9 (2) if **THE DISABLED LAW ENFORCEMENT OFFICER OR RESCUE**  
10 **WORKER WAS DOMICILED IN THE STATE AS OF THE DATE THE DISABLED LAW**  
11 **ENFORCEMENT OFFICER OR RESCUE WORKER WAS ADJUDGED TO BE**  
12 **PERMANENTLY AND TOTALLY DISABLED OR** the fallen law enforcement officer or  
13 rescue worker or the surviving spouse was domiciled in the State as of the date of the  
14 fallen law enforcement officer's or rescue worker's death and the dwelling was  
15 acquired **BY THE DISABLED LAW ENFORCEMENT OFFICER OR RESCUE WORKER**  
16 **WITHIN 2 YEARS OF THE DATE THE DISABLED LAW ENFORCEMENT OFFICER OR**  
17 **RESCUE WORKER WAS ADJUDGED TO BE PERMANENTLY AND TOTALLY**  
18 **DISABLED OR** by the surviving spouse within 2 years of the fallen law enforcement  
19 officer's or rescue worker's death; or

20 (3) if the dwelling was acquired after **THE DISABLED LAW**  
21 **ENFORCEMENT OFFICER OR RESCUE WORKER OR** the surviving spouse qualified  
22 for a credit for a former dwelling under item (1) or (2) of this subsection, to the extent  
23 of the previous credit.

24 (c) A county or municipal corporation may provide, by law, for:

25 (1) the amount and duration of a property tax credit allowed under  
26 this section; and

27 (2) any other provision necessary to carry out the provisions of this  
28 section.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
30 June 1, 2008, and shall be applicable to all taxable years beginning after June 30,  
31 2008.
