5 ~~pension; requiring that the pension be paid at least at certain intervals of time;~~
6 ~~making stylistic changes;~~ permitting certain individuals serving as the Sheriff
7 of Calvert County to participate in the Calvert County Employees' Savings
8 Plan; and generally relating to pensions for sheriffs of Calvert County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article – Courts and Judicial Proceedings**

2 (f) (4) (i) ~~Except as provided in subparagraph (ii) of this paragraph,~~

4 shall receive a pension when ~~he~~ ~~THE SHERIFF~~ leaves office in the annual amount of
5 \$150 for each year served.

9 (ii) This paragraph does not apply to a term of office that begins
10 on or after July 1, 1988.

11 (6) (I) THIS PARAGRAPH APPLIES TO AN INDIVIDUAL WHO:

12 1. ON OR AFTER JULY 1, 2008, SERVES AS THE
13 SHERIFF OF CALVERT COUNTY; AND

14 2. AS THE SHERIFF OF CALVERT COUNTY DOES NOT
15 PARTICIPATE IN THE EMPLOYEES' PENSION SYSTEM UNDER TITLE 23 OF THE
16 STATE PERSONNEL AND PENSIONS ARTICLE.

17 (II) AN INDIVIDUAL DESCRIBED IN SUBPARAGRAPH (I) OF
18 THIS PARAGRAPH MAY PARTICIPATE IN THE CALVERT COUNTY EMPLOYEES'
19 SAVINGS PLAN.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2008.
