16 17 18 19	[The State Board shall adopt regulations that prohibit a county board from knowingly hiring, as a noncertificated employee,] A COUNTY BOARD MAY NOT KNOWINGLY HIRE OR RETAIN any individual who has been convicted of a crime involving:

- 1 (3) A crime of violence as defined in § 14–101 of the Criminal Law 2 Article, or an offense under the laws of another state that would be a violation of § 3 14–101 of the Criminal Law Article if committed in this State.
