- FOR the purpose of altering a certain timeframe for when county boards of education 3 4 and county health departments are required to provide hearing and vision 5 screenings to certain students; authorizing certain screenings in accordance with certain policies; requiring county boards of education and county health 6 7 departments to provide certain forms; requiring certain parents or guardians to 8 report certain information; and generally relating to the provision of hearing 9 and vision screenings in public schools, private schools, and nonpublic educational facilities. 10
