BY repealing and reenacting, with amendments, Article – Public Safety Section 4–201 through 4–204 Annotated Code of Maryland (2003 Volume and 2007 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Public Safety**

- 1 The Treasurer shall invest the money of the Fund in the same manner as $\mathbf{2}$ other State money may be invested. 3 Expenditures from the Fund may only be made: (g) 4 (1) in accordance with the State budget; or 5 by the budget amendment procedure as provided in § 7–209 of the (2)6 State Finance and Procurement Article, if at least 45 days have passed since the 7 budget amendment and supporting information were submitted to the budget committees for their review and comment. 8 9 4-203.10 The [Secretary] **EXECUTIVE DIRECTOR** may make grants to law (a) 11 enforcement agencies from the Fund. 12 The [Secretary] **EXECUTIVE DIRECTOR** shall establish procedures for (b) 13 law enforcement agencies to apply for grants from the Fund and for the evaluation of 14 progress in addressing the problem of drivers illegally failing to stop for school 15 vehicles. 16 When making grants from the Fund, the [Secretary] EXECUTIVE 17 **DIRECTOR** shall consider: 18 the extent of the problem of drivers illegally failing to stop for (1)school vehicles in the area identified by the law enforcement agency applying for a 19 20 grant; 21the law enforcement agency's goals and plans with respect to enhanced enforcement efforts that relate to § 21–706 of the Transportation Article; 2223and 24 other factors that the [Secretary] **EXECUTIVE DIRECTOR** (3)considers appropriate that relate to drivers illegally failing to stop for school vehicles. 2526 (d) Except as provided in paragraph (2) of this subsection, the (1)27[Secretary] **EXECUTIVE DIRECTOR** may not make a grant from the Fund exceeding \$35,000 in a fiscal year for use in a single county. 28
 - awarded in a fiscal year, the [Secretary] **EXECUTIVE DIRECTOR** may make supplemental grants to law enforcement agencies in accordance with procedures established by the [Secretary] **EXECUTIVE DIRECTOR**.
