4	(2) five members of the House of Delegates, appointed by the Speaker.
5 6	(c) The members of the Committee serve at the pleasure of the presiding officer who appointed them.
7 8 9	(d) The President and the Speaker shall jointly appoint a Senator and a Delegate to serve as co-chairmen who shall alternate in serving as the presiding chairman of the Committee each year.
