10 (b) Subject to the other provisions of this section, each year the State shall 11 distribute the State share of the foundation program to each county board.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 July 1, 2008, and shall be applicable to the calculation of payments of State aid for 14 education for fiscal years beginning after June 30, 2009.
