15 16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

19	(a) (1) In this section the following words have the meanings indicated.
$20 \\ 21 \\ 22$	(2) "Facsimile device" means a machine that receives and copies reproductions or facsimiles of documents or photographs that have been transmitted electronically or telephonically over telecommunications lines.



1 2 3	(3) (i) "Commercial solicitation" means the unsolicited electronic or telephonic transmission in the State to a facsimile device to encourage a person to purchase goods, realty, or services.
4	(ii) "Commercial solicitation" does not include:
5 6	1. An electronic or telephonic transmission made in the course of prior negotiations; or
7 8 9	2. An electronic or telephonic transmission made in the course of a preexisting business relationship with the person receiving the transmission.
10 11	(b) A person may not make intentionally an electronic or telephonic transmission to a facsimile device for the purpose of commercial solicitation.
12 13 14	(c) (1) The Attorney General may initiate a civil action against any person who violates this section to recover for the State a penalty not to exceed \$1,000 for each violation.
15 16 17 18	(2) A PERSON THAT RECEIVES AN ELECTRONIC OR TELEPHONIC TRANSMISSION MADE TO THE PERSON'S FACSIMILE DEVICE IN VIOLATION OF THIS SECTION MAY BRING AN ACTION AGAINST A PERSON THAT COMMITS THE VIOLATION TO RECOVER:
19	(I) REASONABLE ATTORNEY'S FEES; AND
20	(II) DAMAGES IN THE AMOUNT OF THE GREATER OF:
21	1. \$500 FOR EACH VIOLATION; OR

23	2. ACTUAL DAMAGES SUSTAINED AS A RESULT OF THE VIOLATION.
