## A BILL ENTITLED

### 1 AN ACT concerning

### 2 Task Force to Study Financial Matters Relating to Long-Term Care Facilities

3 FOR the purpose of establishing a Task Force to Study Financial Matters Relating to 4 Long-Term Care Facilities; providing for the membership and duties of the 5 Task Force; providing for the designation of cochairs of the Task Force; 6 requiring the Department of Legislative Services to provide staff for the Task 7 Force; prohibiting members of the Task Force from receiving certain 8 compensation; authorizing a member to receive certain reimbursement; 9 requiring the Task Force to report its findings and recommendations to the 10 General Assembly on or before a certain date; providing for the termination of this Act; and generally relating to the Task Force to study financial matters 11 relating to long-term care facilities. 12

### 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That:

(a) There is a Task Force to Study Financial Matters Relating to Long–Term
Care Facilities.
