## A BILL ENTITLED

1 AN ACT concerning

2 **Legislative Community Initiatives Loan of 2004 and Maryland Consolidated**  
3 **Capital Bond Loan of 2007 – Washington County – Barbara Ingram School for**  
4 **the Arts**

5 FOR the purpose of amending the Legislative Community Initiatives Loan of 2004 and  
6 the Maryland Consolidated Capital Bond Loan of 2007 to alter the name of a  
7 certain grantee from the Mayor and City Council of the City of Hagerstown to  
8 the Board of Directors of the Hagerstown Neighborhood Development  
9 Partnership, Inc., and generally relating to the Barbara Ingram School for the  
10 Arts.

11 BY repealing and reenacting, with amendments,  
12 Chapter 204 of the Acts of the General Assembly of 2003, as amended by  
13 Chapter 432 of the Acts of the General Assembly of 2004  
14 Section 13(3)(i) Item (BJ)

15 BY repealing and reenacting, with amendments,  
16 Chapter 488 of the Acts of the General Assembly of 2007  
17 Section 1(3) Item ZA02 (CC)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

22 SECTION 13. AND BE IT FURTHER ENACTED, That:

1 (BJ) Barbara Ingram School for the Arts. Provide a grant of  
 2 \$400,000 to the [Mayor and City Council of the City of  
 3 Hagerstown] **BOARD OF DIRECTORS OF THE**  
 4 **HAGERSTOWN NEIGHBORHOOD DEVELOPMENT**  
 5 **PARTNERSHIP, INC.**, for the acquisition, planning, design,  
 6 renovation, reconstruction, and capital equipping of the  
 7 Barbara Ingram School for the Arts, located in Hagerstown,  
 8 subject to a requirement that the grantee provide a matching  
 9 fund of \$270,000 and grant and convey an historic easement  
 10 to the Maryland Historical Trust. Notwithstanding Section  
 11 13(5) of this Act, the matching fund may consist of real  
 12 property, in kind contributions, or funds expended prior to the  
 13 effective date of this Act (Washington County)..... 400,000

14 **Chapter 488 of the Acts of 2007**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That:

17 (3) ZA02 Local Senate Initiatives

18 (CC) Barbara Ingram School for the Arts. Provide a grant equal to  
 19 the lesser of (i) \$150,000 or (ii) the amount of the matching  
 20 fund provided, to the [Mayor and City Council of the City of  
 21 Hagerstown] **BOARD OF DIRECTORS OF THE**  
 22 **HAGERSTOWN NEIGHBORHOOD DEVELOPMENT**  
 23 **PARTNERSHIP, INC.**, for the repair, renovation,  
 24 reconstruction, and capital equipping of the Barbara Ingram  
 25 School for the Arts, located in Hagerstown, subject to a  
 26 requirement that the grantee grant and convey a historic  
 27 easement to the Maryland Historical Trust (Washington  
 28 County)..... 150,000

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
30 June 1, 2008.
