## A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Registration Fees – Discount for Seniors and Individuals with**  
3 **Disabilities**

4 FOR the purpose of providing that for the renewal of a motor vehicle registration a  
5 certain annual registration fee for the motor vehicle shall be reduced by a  
6 certain percentage for disabled individuals and individuals over a certain age if  
7 all owners of the vehicle meet certain requirements and the vehicle is driven  
8 less than a certain number of miles annually; requiring individuals to certify  
9 certain information to qualify for a fee reduction under this Act; requiring a  
10 certain certification to be made on a form provided by the Motor Vehicle  
11 Administration; providing that a certain fee reduction does not apply to the first  
12 issuance of a registration to the owner of a motor vehicle after title or interest  
13 transfers to that owner; providing for the application of this Act; and generally  
14 relating to vehicle registration fees.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

1           (A)    THE PROVISIONS OF THIS SECTION DO NOT APPLY TO THE FIRST  
2 ISSUANCE OF A REGISTRATION TO THE OWNER OF A MOTOR VEHICLE AFTER  
3 THE TITLE OR INTEREST IN THE VEHICLE TRANSFERS TO THAT OWNER.

4           (B)    (1)   NOTWITHSTANDING ANY OTHER PROVISION OF THIS  
5 SUBTITLE, FOR THE RENEWAL OF THE REGISTRATION OF A MOTOR VEHICLE  
6 FOR WHICH SPECIAL REGISTRATION PLATES HAVE BEEN ISSUED UNDER §  
7 13-616 OF THIS TITLE, THE ANNUAL REGISTRATION FEE SPECIFIED IN THIS  
8 SUBTITLE SHALL BE REDUCED BY 50% IF:

9                       (I)    ALL OF THE OWNERS OF THE MOTOR VEHICLE MEET  
10 THE DISABILITY REQUIREMENTS OF § 13-616(B)(1) OF THIS TITLE;

11                      (II)   THE MOTOR VEHICLE IS DRIVEN 5,000 MILES OR LESS  
12 ANNUALLY;

13                      (III)   THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF  
14 EACH OF THE OWNERS OF THE MOTOR VEHICLE DOES NOT EXCEED \$30,000 OR  
15 \$60,000 IN THE CASE OF MARRIED INDIVIDUALS FILING A JOINT RETURN; AND

16                      (IV)   THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF  
17 ALL OF THE OWNERS OF THE MOTOR VEHICLE COMBINED DOES NOT EXCEED  
18 \$60,000.

19           (2)    IN ORDER TO QUALIFY FOR THE FEE REDUCTION UNDER THIS  
20 SUBSECTION, ALL OWNERS OF THE MOTOR VEHICLE SHALL CERTIFY THE  
21 FOLLOWING:

22                      (I)    THAT ALL OF THE OWNERS OF THE MOTOR VEHICLE  
23 MEET THE DISABILITY REQUIREMENTS OF § 13-616(B)(1) OF THIS TITLE;

24                      (II)   THAT THE MOTOR VEHICLE HAS BEEN ISSUED A  
25 SPECIAL DISABLED INDIVIDUAL'S REGISTRATION NUMBER AND SPECIAL  
26 REGISTRATION PLATES UNDER § 13-616(B) OF THIS TITLE;

27                      (III)   THAT THE MOTOR VEHICLE IS DRIVEN 5,000 MILES OR  
28 LESS ANNUALLY;

29                      (IV)   THE MOTOR VEHICLE'S ODOMETER READING AT THE  
30 TIME OF THE CERTIFICATION; AND

31                      (V)    THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF  
32 EACH OF THE OWNERS OF THE MOTOR VEHICLE.

1           **(3) THE CERTIFICATION REQUIRED UNDER PARAGRAPH (2) OF**  
2 **THIS SUBSECTION SHALL BE MADE ON A FORM PROVIDED BY THE**  
3 **ADMINISTRATION.**

4           **(C) (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS**  
5 **SUBTITLE, FOR A MOTOR VEHICLE OWNED BY AN INDIVIDUAL WHO IS AT LEAST**  
6 **70 YEARS OF AGE AT THE TIME OF THE RENEWAL OF THE VEHICLE'S**  
7 **REGISTRATION, THE ANNUAL REGISTRATION FEE SPECIFIED IN THIS SUBTITLE**  
8 **FOR THE RENEWAL OF THE REGISTRATION SHALL BE REDUCED BY 50% IF:**

9                   **(I) ALL OF THE OWNERS OF THE VEHICLE ARE AT LEAST 70**  
10 **YEARS OF AGE AT THE TIME OF THE RENEWAL OF THE REGISTRATION;**

11                   **(II) THE MOTOR VEHICLE IS DRIVEN 5,000 MILES OR LESS**  
12 **ANNUALLY;**

13                   **(III) THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF**  
14 **EACH OF THE OWNERS OF THE MOTOR VEHICLE DOES NOT EXCEED \$30,000 OR**  
15 **\$60,000 IN THE CASE OF MARRIED INDIVIDUALS FILING A JOINT RETURN; AND**

16                   **(IV) THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF**  
17 **ALL OF THE OWNERS OF THE MOTOR VEHICLE COMBINED DOES NOT EXCEED**  
18 **\$60,000.**

19           **(2) IN ORDER TO QUALIFY FOR THE FEE REDUCTION UNDER THIS**  
20 **SUBSECTION, ALL OWNERS OF THE MOTOR VEHICLE SHALL CERTIFY THE**  
21 **FOLLOWING:**

22                   **(I) THAT ALL OF THE OWNERS OF THE MOTOR VEHICLE**  
23 **ARE AT LEAST 70 YEARS OF AGE AT THE TIME OF THE RENEWAL OF THE**  
24 **REGISTRATION;**

25                   **(II) THAT THE MOTOR VEHICLE IS DRIVEN 5,000 MILES OR**  
26 **LESS ANNUALLY;**

27                   **(III) THE MOTOR VEHICLE'S ODOMETER READING AT THE**  
28 **TIME OF THE CERTIFICATION; AND**

29                   **(IV) THE ANNUAL FEDERAL ADJUSTED GROSS INCOME OF**  
30 **EACH OF THE OWNERS OF THE MOTOR VEHICLE.**

31           **(3) THE CERTIFICATION REQUIRED UNDER PARAGRAPH (2) OF**  
32 **THIS SUBSECTION SHALL BE MADE ON A FORM PROVIDED BY THE**  
33 **ADMINISTRATION.**

1       SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be  
2 construed to apply only prospectively and may not be applied or interpreted to have  
3 any effect on or application to any registration fee paid before the effective date of this  
4 Act.

5       SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
6 October 1, 2008.
