AND BE IT FURTHER ENACTED, That this Act applies to any lot released by the Maryland Agricultural Land Preservation Foundation on or after the effective date of this Act, under the terms of any agricultural land preservation easement, even if the easement was granted to the Foundation before October 1, 2008.
10 11	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
