BY repealing and reenacting, without amendments, Article - Election Law Section 4–202(a) and (f) and 4–203(h) Annotated Code of Maryland (2003 Volume and 2007 Supplement) BY repealing Chapter 570 of the Acts of the General Assembly of 2006 Section 2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Election Law 4-202.A principal political party shall elect the members of the county (a) central committee at a primary election.

- 31 (3) Any vacancy in a seat on the Central Committee held by an 32 individual elected from a county commissioner district shall be filled by an individual 33 who resides in that district.

1 2 3	[SECTION 2. AND BE IT FURTHER ENACTED, That, subject to § 4–202(f) of the Election Law Article, the terms of the members of the Worcester County Democratic Party Central Committee elected under this Act shall expire as follows:
4 5 6	(1) the term of the member elected at the November 2006 election from county commissioner district 1, 4, 6, and 7 shall expire after the November 2010 election, and then expire each four years thereafter;
7 8 9	(2) the term of the member elected at the November 2006 election from county commissioner district 2, 3, and 5 shall expire after the November 2008 election, and then expire each four years thereafter; and
10 11 12 13	(3) (i) the term of each of the two members elected from the county at large at the November 2006 election who receive the highest and second highest number of votes cast at that election shall expire after the November 2010 election, and then expire each four years thereafter; and
14 15 16 17	(ii) the term of each of the two members elected from the county at large at the November 2006 election who receive the third and fourth highest number of votes cast at that election shall expire after the November 2008 election, and then expire each four years thereafter.]
