19 20	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 2 (A) IN THIS SECTION, "PULL TAB OR INSTANT BINGO" MEANS A
  3 PREDETERMINED FINITE GAME OF CHANCE THAT USES PAPER TICKETS
- 4 DISPENSED MANUALLY OR MECHANICALLY WITH CONCEALED NUMBERS OR
- 5 SYMBOLS THAT, WHEN EXPOSED TO THE PLAYER, DETERMINE WHETHER THE
- 6 PLAYER WINS OR LOSES, BASED ON THE MATCH OF THE NUMBERS OR SYMBOLS
- 7 TO THE FLARE OR SEAL CARD OF THE GAME.
- 8 **[(a)] (B)** A benefit performance shall be personally managed and conducted only by members of the qualified organization that sponsors the benefit performance.
- 10 [(b)] (C) (1) At a benefit performance, a qualified organization may:
- 11 (i) conduct games of skill; or
- 12 (ii) dispose of merchandise and other things of value by auction.
- voting, or using a mechanical device such as a paddle wheel, wheel of fortune, bingo,
- 14 **PULL TAB OR INSTANT BINGO,** or similar device.
- 15 (2) The activities allowed under this subsection may be conducted with 16 or without an entrance or participation fee.
- 17 (D) A PERSON MAY NOT USE AN ELECTRONIC DISPENSER IN AN
- 18 ACTIVITY ALLOWED UNDER SUBSECTION (C)(1)(II) OF THIS SECTION IN WHICH
- 19 THE WINNING PULL TABS:
- 20 (1) ARE NOT RANDOMLY DISTRIBUTED AND MIXED AMONG ALL
- 21 PULL TABS;
- 22 (2) CAN BE DETERMINED IN ADVANCE OF OPENING THE PULL
- 23 TABS MANUALLY OR MECHANICALLY; OR
- 24 (3) EXCEED THE PRIZE LIMITATIONS ESTABLISHED BY THE
- 25 PRINCE GEORGE'S COUNTY COUNCIL BY LOCAL ORDINANCE FOR PULL TAB OR
- 26 INSTANT BINGO.
- 27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 28 July 1, 2008.
