- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

#### Article – Education

18 3–1003.

(a) From and after December 4, 2006, at the beginning of each member's full
term, the chairman of the County Board is entitled to receive \$19,000 annually as
compensation and the other elected members are each entitled to receive \$18,000
annually as compensation.

# INCREASE AT A RATE EQUAL TO ANY ANNUAL INCREASE IN TEACHERS' SALARIES IN THE COUNTY FOR THAT SAME YEAR.

3 [(b)] (C) (1) After submitting vouchers under the rules and regulations 4 adopted by the County Board, the chairman and the other members, including the 5 student member, are entitled to the allowances for travel and other expenses provided 6 in the Prince George's County budget.

7 (2) A member of the County Board may not be reimbursed more than
8 \$7,000 in travel and other expenses incurred in a single fiscal year.

9 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 10 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 11 the salary or compensation of the chairman and other elected members of the Prince 12 George's County Board of Education in office on the effective date of this Act, but the 13 provisions of this Act concerning the salary or compensation of the chairman and other 14 elected members of the Prince George's County Board of Education shall take effect at 15 the beginning of the next following term of office.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2008.
