4 FOR the purpose of repealing certain provisions of law relating to the composition of
5 certain school board districts in Prince George's County; requiring the elected
6 members of the Prince George's County Board of Education to be elected from
7 certain school board districts; providing for the boundaries of certain school
8 board districts; requiring candidates for the County Board to live in certain
9 school board districts and be registered voters; providing for the terms of the
10 elected members of the County Board; requiring a certain vacancy on the
11 County Board to be filled by a special election if the vacancy occurs within a
12 certain time period; requiring that a certain vacancy on the County Board
13 remain unfilled under certain circumstances; requiring the Prince George's
14 County Council to adopt a certain resolution concerning a special election for
15 the County Board; requiring a special election for the County Board to be
16 conducted at a certain time and in a certain manner under certain provisions of
17 law; requiring that a special election for the County Board be funded by Prince
18 George's County; clarifying that a school board member removed from office is
19 entitled to judicial review of the removal based on a certain record and certain
20 other evidence; repealing certain provisions of law relating to public meetings
21 and executive sessions of the County Board; requiring a certain vote of the
22 County Board to pass a motion of the County Board when there are two or more
23 vacancies on the County Board; repealing a certain provision of law relating to
24 the composition of a committee of the County Board; repealing certain

22 (a) In this subtitle, “elected member” means [one of the nine elected
23 members] **A MEMBER** of the Prince George’s County Board [or a member appointed to
24 fill a vacancy of one of these nine members] **ELECTED FROM ONE OF THE NINE**
25 **SCHOOL BOARD DISTRICTS DESCRIBED IN § 3-1001 OF THIS SUBTITLE.**

26 (b) The Prince George’s County Board consists of 10 members as follows:

1 (1) [Five] **NINE** elected members, each of whom resides in a different
2 school board district; **AND**

3 [(2) Four elected members who may reside anywhere in the county;
4 and

5 (3)](2) One student member selected under subsection (f)(2) of this
6 section.

7 (c) (1) [A candidate for the County Board shall be a resident of Prince
8 George's County for at least 3 years and a registered voter of the county before the
9 election] **ONE MEMBER OF THE COUNTY BOARD SHALL BE ELECTED FROM EACH**
10 **OF THE NINE SCHOOL BOARD DISTRICTS DESCRIBED IN § 3-1001 OF THIS**
11 **SUBTITLE.**

12 (2) From the time of filing as a candidate for election, each candidate
13 [for a position on the County Board representing a school board district shall reside in
14 the school board district the candidate seeks to represent] **SHALL BE A REGISTERED**
15 **VOTER OF THE COUNTY AND A RESIDENT OF THE SCHOOL BOARD DISTRICT THE**
16 **CANDIDATE SEEKS TO REPRESENT.**

17 (3) An elected County Board member shall forfeit the office if the
18 member:

19 (i) [In the case of a member elected to represent a school board
20 district, fails] **FAILS** to reside in the school board district from which the member was
21 elected, unless this change is caused by a change in the boundaries of the district; or

22 (ii) Fails to be a registered voter of the county.

23 (4) A County Board member may not hold another office of profit in
24 county government during the member's term.

25 (5) Each elected member of the County Board [for a position
26 representing a school board district] shall be nominated by the registered voters of the
27 member's school board district.

28 (d) [Members of the Prince George's County Board shall be elected:

29 (1) At the general election every 4 years as required by subsection (g)
30 of this section; and

31 (2) By the registered voters of the entire county.]

32 **THE ELECTED MEMBERS OF THE COUNTY BOARD SHALL BE**
33 **ELECTED:**

1 **(1) AT THE GENERAL ELECTION EVERY 4 YEARS AS REQUIRED BY**
2 **SUBSECTION (G) OF THIS SECTION; AND**

3 **(2) BY THE VOTERS OF THE SCHOOL BOARD DISTRICT THAT EACH**
4 **MEMBER REPRESENTS.**

5 (e) (1) If a candidate for the County Board dies or withdraws the
6 candidacy during the period beginning with the date of the primary and ending 70
7 days before the date of the general election, the Board of [Supervisors of] Elections
8 shall:

9 (i) Replace the name of the deceased or withdrawn candidate
10 on the ballot for the general election with the name of the candidate who received the
11 next highest number of votes in the primary election; or

12 (ii) If a contested primary was not held, reopen the filing
13 process to allow other persons to file as candidates.

14 (2) (i) Except as otherwise provided in subparagraph (ii) of this
15 paragraph, the Board of [Supervisors of] Elections shall add to the ballot for the
16 general election the name of any person who files as a candidate in accordance with
17 paragraph (1)(ii) of this subsection.

18 (ii) The Board of [Supervisors of] Elections may not add
19 additional candidates to the ballot for the general election within 70 days before the
20 date of the election.

21 (f) (1) The student member shall be an eleventh or twelfth grade student
22 in the Prince George's County public school system during the student's term in office.

23 (2) An eligible student shall file a nomination form at least 2 weeks
24 before a special election meeting of the Prince George's Regional Association of
25 Student Governments. Nomination forms shall be made available in the
26 administrative offices of all public senior high schools in the county, the office of
27 student concerns, and the office of the president of the regional association. The
28 delegates to the regional association annually shall elect the student member to the
29 Board at a special election meeting to be held each school year.

30 (3) The student member may vote on all matters before the Board
31 except those relating to:

32 (i) Capital and operating budgets;

33 (ii) School closings, reopenings, and boundaries;

34 (iii) Collective bargaining decisions;

1 (iv) Student disciplinary matters;

2 (v) Teacher and administrator disciplinary matters as provided
3 under § 6–202(a) of this article; and

4 (vi) Other personnel matters.

5 (4) On an affirmative vote of a majority of the elected members of the
6 County Board, the Board may determine if a matter before the Board relates to a
7 subject that the student member may not vote on under paragraph (3) of this
8 subsection.

9 (5) Unless invited to attend by an affirmative vote of a majority **OF**
10 **THE ELECTED MEMBERS** of the County Board, the student member may not attend
11 an executive session that relates to hearings on appeals of special education
12 placements, hearings held under § 6–202(a) of this article, or collective bargaining.

13 (6) The Prince George’s Regional Association of Student Governments
14 may establish procedures for the election of the student member of the County Board.

15 (7) The election procedures established by the Prince George’s
16 Regional Association of Student Governments are subject to the approval of the elected
17 members of the County Board.

18 (g) (1) **[An] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
19 **SUBSECTION, AN** elected member serves for a term of 4 years beginning on the first
20 Monday in December after the member’s election and until the member’s successor is
21 elected and qualifies.

22 (2) **THE TERMS OF THE ELECTED MEMBERS ARE STAGGERED AS**
23 **FOLLOWS:**

24 (I) **THE FIVE ELECTED MEMBERS WHO RECEIVED THE**
25 **LOWEST PERCENTAGE OF VOTES, AS DETERMINED BY THE FINAL VOTE COUNT**
26 **OF THE 2010 GENERAL ELECTION AS CERTIFIED BY THE BOARD OF**
27 **ELECTIONS, SHALL SERVE FOR A TERM OF 2 YEARS; AND**

28 (II) **THE OTHER FOUR MEMBERS ELECTED IN THE 2010**
29 **GENERAL ELECTION SHALL SERVE FOR A TERM OF 4 YEARS.**

30 [(2)] (3) The student member serves for a term of 1 year beginning at
31 the end of a school year.

32 [(3) Subject to the confirmation of the County Council, the County
33 Executive of Prince George’s County shall appoint a qualified individual to fill any

1 vacancy on the County Board until a successor is elected and qualifies at the next
2 congressional election.]

3 (4) (I) 1. A SEAT ON THE COUNTY BOARD HELD BY AN
4 ELECTED MEMBER THAT BECOMES VACANT MORE THAN 180 DAYS BEFORE THE
5 END OF THAT MEMBER'S TERM OF OFFICE SHALL BE FILLED FOR THE
6 REMAINDER OF THE TERM AT A SPECIAL ELECTION.

7 2. A SEAT ON THE COUNTY BOARD HELD BY AN
8 ELECTED MEMBER THAT BECOMES VACANT 180 DAYS OR LESS BEFORE THE END
9 OF THAT MEMBER'S TERM OF OFFICE SHALL REMAIN VACANT UNTIL A
10 SUCCESSOR IS ELECTED AND QUALIFIES.

11 (II) 1. A. NO LATER THAN 7 DAYS AFTER THE
12 OCCURRENCE OF A VACANCY ON THE COUNTY BOARD THAT MUST BE FILLED AT
13 A SPECIAL ELECTION, THE COUNTY COUNCIL SHALL ADOPT A RESOLUTION
14 DIRECTING THAT A SPECIAL PRIMARY ELECTION AND SPECIAL GENERAL
15 ELECTION BE HELD IN THE SCHOOL BOARD DISTRICT WHERE THE VACANCY
16 OCCURS.

17 B. THE COUNTY COUNCIL SHALL CONSULT WITH
18 THE BOARD OF ELECTIONS BEFORE ADOPTING THE RESOLUTION.

19 2. SUBJECT TO SUBPARAGRAPH (III) OF THIS
20 PARAGRAPH, THE COUNTY COUNCIL RESOLUTION SHALL SPECIFY:

21 A. THE DATE BY WHICH A CERTIFICATE OF
22 CANDIDACY MUST BE FILED WITH THE BOARD OF ELECTIONS;

23 B. THE DATE OF THE SPECIAL PRIMARY ELECTION;
24 AND

25 C. THE DATE OF THE SPECIAL GENERAL ELECTION.

26 3. NO LATER THAN 7 DAYS AFTER THE ADOPTION OF
27 THE COUNTY COUNCIL RESOLUTION, THE BOARD OF ELECTIONS SHALL
28 PUBLISH THE INFORMATION CONTAINED IN THE RESOLUTION ONCE IN AT
29 LEAST ONE NEWSPAPER OF GENERAL CIRCULATION.

30 (III) 1. A CANDIDATE SHALL FILE A CERTIFICATE OF
31 CANDIDACY WITH THE BOARD OF ELECTIONS NO LATER THAN 28 DAYS BEFORE
32 A SPECIAL PRIMARY ELECTION IN ORDER TO APPEAR ON THE BALLOT.

33 2. THE FOLLOWING PROVISIONS ARE SUBJECT TO
34 SUBSUBPARAGRAPH 3 OF THIS SUBPARAGRAPH:

1 **A. A SPECIAL PRIMARY ELECTION SHALL BE HELD**
2 **ON A TUESDAY AT LEAST 45 DAYS BUT NO LATER THAN 60 DAYS AFTER THE**
3 **OCCURRENCE OF A VACANCY.**

4 **B. A SPECIAL GENERAL ELECTION SHALL BE HELD**
5 **ON A TUESDAY AT LEAST 60 DAYS BUT NO LATER THAN 90 DAYS AFTER THE**
6 **OCCURRENCE OF A VACANCY.**

7 **3. A SPECIAL ELECTION MAY NOT BE HELD LESS**
8 **THAN 30 DAYS BEFORE A REGULARLY SCHEDULED ELECTION.**

9 **4. ON THE DAY OF A SPECIAL ELECTION, POLLING**
10 **PLACES SHALL BE OPEN FROM 7 A.M. TO 8 P.M.**

11 **(IV) 1. NO LATER THAN 10 DAYS BEFORE A SPECIAL**
12 **PRIMARY ELECTION AND SPECIAL GENERAL ELECTION, THE BOARD OF**
13 **ELECTIONS SHALL MAIL A SPECIMEN BALLOT TO THE HOUSEHOLD OF EACH**
14 **REGISTERED VOTER IN THE SCHOOL BOARD DISTRICT WHERE THE VACANCY**
15 **OCCURS.**

16 **2. THE SPECIMEN BALLOT SHALL INCLUDE THE**
17 **NAMES OF THE CANDIDATES IN THE ORDER AND FORM IN WHICH THEY ARE TO**
18 **APPEAR ON THE BALLOT, TOGETHER WITH A STATEMENT, NOT TO EXCEED 500**
19 **WORDS, PROVIDED BY EACH CANDIDATE.**

20 **(V) 1. PRINCE GEORGE'S COUNTY SHALL FUND A**
21 **SPECIAL ELECTION HELD UNDER THIS PARAGRAPH.**

22 **2. THE BOARD OF ELECTIONS SHALL SUBMIT A**
23 **REQUEST FOR A SUPPLEMENTAL BUDGET APPROPRIATION TO THE DIRECTOR**
24 **OF THE OFFICE OF MANAGEMENT AND BUDGET TO COVER THE COST OF A**
25 **SPECIAL ELECTION NO LATER THAN 60 DAYS AFTER THE ELECTION.**

26 **(VI) A SPECIAL ELECTION UNDER THIS PARAGRAPH SHALL**
27 **BE GOVERNED BY TITLE 8, SUBTITLE 8 OF THE ELECTION LAW ARTICLE AND**
28 **ALL OTHER RELEVANT PROVISIONS OF LAW RELATING TO THE CONDUCT OF**
29 **ELECTIONS EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE OR WHERE**
30 **SUCH CONSTRUCTION WOULD BE UNREASONABLE.**

31 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
32 read as follows:

1 3-1002.

2 (h) (1) With the approval of the Governor, the State Board may remove a
3 member of the County Board for any of the following reasons:

- 4 (i) Immorality;
- 5 (ii) Misconduct in office;
- 6 (iii) Incompetency; or
- 7 (iv) Willful neglect of duty.

8 (2) Before removing a member, the State Board shall send the member
9 a copy of the charges pending and give the member an opportunity within 10 days to
10 request a hearing.

11 (3) If the member requests a hearing within the 10-day period:

12 (i) The State Board promptly shall hold a hearing, but a
13 hearing may not be set within 10 days after the State Board sends the member a
14 notice of the hearing; and

15 (ii) The member shall have an opportunity to be heard publicly
16 before the State Board in the member's own defense, in person or by counsel.

17 (4) A member removed under this subsection has the right to [a de
18 novo] **JUDICIAL** review of the removal by the Circuit Court for Prince George's County
19 **BASED ON AN ADMINISTRATIVE RECORD AND SUCH ADDITIONAL EVIDENCE AS**
20 **WOULD BE AUTHORIZED BY § 10-222(F) AND (G) OF THE STATE GOVERNMENT**
21 **ARTICLE.**

22 (i) While serving on the County Board, a member may not be a candidate for
23 a public office other than a position on the County Board.

24 3-1003.

25 (a) From and after December 4, 2006, at the beginning of each member's full
26 term, the [chairman] **CHAIR** of the County Board is entitled to receive \$19,000
27 annually as compensation and the other elected members are each entitled to receive
28 \$18,000 annually as compensation.

29 (b) (1) After submitting vouchers under the rules and regulations adopted
30 by the County Board, the [chairman] **CHAIR** and the other members, including the
31 student member, are entitled to the allowances for travel and other expenses provided
32 in the Prince George's County budget.

1 (2) A member of the County Board may not be reimbursed more than
2 \$7,000 in travel and other expenses incurred in a single fiscal year.

3 3-1004.

4 (a) The County Board shall hold an annual meeting on the first Monday in
5 December to elect a [chairman] **CHAIR** and vice [chairman] **CHAIR** from among its
6 members.

7 (b) [All actions of the County Board shall be taken at a public meeting and a
8 record of the meeting and all actions shall be made public.

9 (c) This section does not prohibit the County Board from meeting and
10 deliberating in executive session provided that all action of the County Board, together
11 with the individual vote of each member, is contained in a public record.

12 (d)] (1) Except as otherwise provided in paragraph (2) of this subsection,
13 the affirmative vote of the members of the County Board for the passage of a motion
14 by the County Board shall be:

15 (i) Six members when the student member is voting; or

16 (ii) Five members when the student member is not voting.

19 passage of a motion by the Board shall be five members.] **WHEN THERE ARE TWO OR

21 MEMBERS OF THE COUNTY BOARD FOR THE PASSAGE OF A MOTION BY THE
22 BOARD SHALL BE:**

23 (I) **FIVE MEMBERS WHEN THE STUDENT MEMBER IS
24 VOTING; OR**

25 (II) **FOUR MEMBERS WHEN THE STUDENT MEMBER IS NOT
26 VOTING.**

27 3-1006.

28 [(a)] In addition to the powers otherwise granted to the County Board in this
29 article, the County Board or a designated committee of the County Board may hear an
30 appeal from a decision of the County Superintendent that relates to the grade,
31 transfer, tuition, or any aspect of participation in a program or activity of a specific
32 student who is not subject to the provisions of Title 8, Subtitle 4 of this article.

1 [(b) A designated committee shall consist of at least 5 members of the Board
2 and at least 5 members of a designated committee shall be present to constitute a
3 quorum of the committee.]

4 [3-1008.

5 (a) There is a Chief Financial Officer in the Prince George’s County public
6 school system who shall:

7 (1) Be responsible for the day-to-day management and oversight of
8 the fiscal affairs of the Prince George’s County public school system; and

9 (2) Report directly to the County Superintendent.

10 (b) The County Superintendent shall, subject to the approval of the County
11 Board:

12 (1) Select the Chief Financial Officer; and

13 (2) Establish the salary of the Chief Financial Officer.

14 (c) The employment contract of the Chief Financial Officer shall provide that
15 continued employment is contingent on the effective fiscal management of the Prince
16 George’s County public schools.

17 (d) The Chief Financial Officer is not a public officer under the Constitution
18 or the laws of the State.]

19 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
20 take effect July 1, 2010.

21 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in
22 Section 3 of this Act, this Act shall take effect July 1, 2008.
