- 1 "voice over Internet protocol service" or "VoIP service" means any **(1)** $\mathbf{2}$ service that: 3 (i) enables real-time two-way voice communications that 4 originate from or terminate to the subscriber end user's location requiring Internet protocol or any successor protocol to Internet protocol; and 5 6 (ii) requires a broadband connection from the user's location; 7 and "voice over Internet protocol service" or "VoIP service" includes any 8 (2)9 such service that permits users generally to receive calls that originate on the public 10 switched telephone network and to terminate calls to the public switched telephone 11 network. 12 8-603. 13 A VOIP SERVICE DOING BUSINESS IN THE STATE SHALL NOTIFY (A) 14 EACH CUSTOMER, ON ACTIVATION OF VOIP SERVICE TO THE CUSTOMER, OF 15 THE LIMITATIONS OF THE VOIP SERVICE RELATING TO THE 9-1-1 SYSTEM IN A 16 **COMPLIES** AND **STATE** MANNER **THAT** WITH **FEDERAL** RULES **AND** 17 REGULATIONS. 18 FOR EACH VOIP SERVICE DOING BUSINESS IN THE STATE THAT 19 PROVIDES THE REGISTERED PHYSICAL LOCATION AND CALLBACK NUMBER OF A 20 CALLER TO A 9-1-1 SYSTEM IN THE STATE, THE VOIP SERVICE SHALL REQUIRE 21EACH CUSTOMER WHO IS BILLED OR LOCATED IN THE STATE TO UPDATE WITH 22 THE VOIP SERVICE THE PHYSICAL LOCATION AT WHICH THE VOIP SERVICE 23 WILL BE USED EACH MONTH BY THE CUSTOMER.
