Public Safety - DNA Sample Collection on Arrest - Undocumented Aliens

- FOR the purpose of requiring the collection of a DNA sample from an individual under arrest and determined to be an undocumented alien; altering a certain definition; requiring a DNA sample to be collected at the facility where a certain arrest is processed; providing that a certain DNA record may be expunged under certain circumstances; and generally relating to the collection of DNA samples.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:
- 16 Article Public Safety
- 17 2–501.
- 18 (a) In this subtitle the following words have the meanings indicated.
- 19 (b) (1) "CODIS" means the Federal Bureau of Investigation's "Combined 20 DNA Index System" that allows the storage and exchange of DNA records submitted 21 by federal, state and local forensic DNA laboratories.
- 22 (2) "CODIS" includes the national DNA index administered and operated by the Federal Bureau of Investigation.



- 1 (c) "Crime Laboratory" means the Crime Laboratory Division of the 2 Department.
- 3 (d) "Director" means the Director of the Crime Laboratory or the Director's designee.
- 5 (e) "DNA" means deoxyribonucleic acid.
- 6 (f) (1) "DNA record" means DNA information stored in CODIS or the statewide DNA data base system.
- 8 (2) "DNA record" includes the information commonly referred to as a 9 DNA profile.
- 10 (g) "DNA sample" means a body fluid or tissue sample that is:
- 11 (1) provided by an individual who is convicted of a felony or a violation 12 of § 6–205 or § 6–206 of the Criminal Law Article; [or]
- 13 (2) submitted to the statewide DNA data base system for analysis as 14 part of a criminal investigation; **OR**
- 15 (3) PROVIDED BY AN INDIVIDUAL WHO HAS BEEN ARRESTED BY A
 16 LAW ENFORCEMENT OFFICER AND WHO HAS BEEN DETERMINED TO BE AN
 17 UNDOCUMENTED ALIEN.
- 18 (h) "Statewide DNA data base system" means the DNA record system 19 administered by the Department for identification purposes.
- 20 (i) "Statewide DNA repository" means the State repository of DNA samples 21 collected under this subtitle.
- 22 2–504.
- 23 (a) (1) In accordance with regulations adopted under this subtitle, an individual who is convicted of a felony or a violation of § 6–205 or § 6–206 of the Criminal Law Article shall:
- 26 (i) have a DNA sample collected either at the time of sentence 27 or on intake to a correctional facility, if the individual is sentenced to a term of 28 imprisonment; or
- 29 (ii) provide a DNA sample as a condition of sentence or 30 probation, if the individual is not sentenced to a term of imprisonment.
- 31 (2) An individual who was convicted of a felony or a violation of \S 32 6–205 or \S 6–206 of the Criminal Law Article on or before October 1, 2003 and who

- remains confined in a correctional facility on or after October 1, 1999, shall submit a DNA sample to the Department.
- 3 (3) AN INDIVIDUAL WHO HAS BEEN ARRESTED BY A LAW 4 ENFORCEMENT OFFICER AND WHO HAS BEEN DETERMINED TO BE AN 5 UNDOCUMENTED ALIEN SHALL SUBMIT A DNA SAMPLE TO THE DEPARTMENT.
- 6 (b) In accordance with regulations adopted under this subtitle, each DNA sample required to be collected under this section shall be collected:
- 8 (1) AT THE FACILITY WHERE THE ARREST OF THE INDIVIDUAL IS 9 PROCESSED;
- 10 [(1)] (2) at the correctional facility where the individual is confined, 11 if the individual is confined in a correctional facility on or after October 1, 2003, or is 12 sentenced to a term of imprisonment on or after October 1, 2003;
- 13 [(2)] (3) at a facility specified by the Director, if the individual is on probation or is not sentenced to a term of imprisonment; or
- 15 [(3)] **(4)** at a suitable location in a circuit court following the 16 imposition of sentence.
- 17 (c) A DNA sample shall be collected by an individual who is:
- 18 (1) designated by the Director; and
- 19 (2) trained in the collection procedures that the Crime Laboratory 20 uses.
- 21 (d) A second DNA sample shall be taken if needed to obtain sufficient DNA 22 for the statewide DNA data base or if ordered by the court for good cause shown.
- (e) Failure of an individual who is not sentenced to a term of imprisonment to provide a DNA sample within 90 days after notice by the Director is a violation of probation.

- 27 (a) An individual whose DNA record or profile is included in the statewide DNA data base system and whose DNA sample is stored in the statewide DNA repository may request that information be expunged on the grounds that the **ARREST** 30 **OR** conviction that resulted in the inclusion meets the expungement criteria specified in § 10–105 or § 10–106 of the Criminal Procedure Article.
- 32 (b) Expungement proceedings shall be conducted in accordance with § 33 10–105 or § 10–106 of the Criminal Procedure Article.

- (c) On receipt of an order of expungement, the Director shall purge any DNA record, DNA sample, or other identifiable information covered by the order from the statewide DNA data base system and the statewide DNA repository.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2008.
