## A BILL ENTITLED

1 AN ACT concerning

2 **Texting While Driving Ban of 2008**

3 FOR the purpose of prohibiting the use of a wireless communication device to write,  
4 send, or read a text message while operating a moving motor vehicle;  
5 establishing certain exceptions to the prohibition; providing that certain use of a  
6 wireless communication device does not constitute writing, sending, or reading  
7 a text message for purposes of this Act; and generally relating to the use of a  
8 wireless communication device while operating a motor vehicle.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

1           **(A) (1) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A**  
2 **PERSON MAY NOT USE A WIRELESS COMMUNICATION DEVICE TO WRITE, SEND,**  
3 **OR READ A TEXT MESSAGE WHILE OPERATING A MOVING MOTOR VEHICLE.**

4           **(2) FOR THE PURPOSES OF THIS SECTION, READING, SELECTING,**  
5 **OR ENTERING A PHONE NUMBER OR NAME IN A WIRELESS COMMUNICATION**  
6 **DEVICE TO MAKE A PHONE CALL DOES NOT CONSTITUTE WRITING, SENDING, OR**  
7 **READING A TEXT MESSAGE.**

8           **(B) SUBSECTION (A) OF THIS SECTION DOES NOT APPLY TO AN**  
9 **OPERATOR OF:**

10           **(1) A MOVING EMERGENCY VEHICLE WHILE ACTING IN AN**  
11 **OFFICIAL CAPACITY;**

12           **(2) A MOVING MOTOR VEHICLE WHILE USING A WIRELESS**  
13 **COMMUNICATION DEVICE TO:**

14                   **(I) REPORT UNLAWFUL ACTIVITY;**

15                   **(II) SUMMON MEDICAL OR OTHER EMERGENCY**  
16 **ASSISTANCE;**

17                   **(III) PREVENT INJURY TO A PERSON OR PROPERTY; OR**

18                   **(IV) RELAY INFORMATION BETWEEN A TRANSIT OR**  
19 **FOR-HIRE OPERATOR AND THAT OPERATOR'S DISPATCHER, WHERE THE DEVICE**  
20 **IS PERMANENTLY AFFIXED TO THE VEHICLE; OR**

21           **(3) A MOVING MOTOR VEHICLE WHILE USING A GLOBAL**  
22 **POSITIONING SYSTEM.**

24           (a) It is a misdemeanor for any person to violate any of the provisions of the  
25 Maryland Vehicle Law unless the violation:

26                   (1) Is declared to be a felony by the Maryland Vehicle Law or by any  
27 other law of this State; or

28                   (2) Is punishable by a civil penalty under the applicable provision of  
29 the Maryland Vehicle Law.

1           (b)    Except as otherwise provided in this section, any person convicted of a  
2 misdemeanor for the violation of any of the provisions of the Maryland Vehicle Law is  
3 subject to a fine of not more than \$500.

4           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 October 1, 2008.
