T	(I) BETWEEN ANY TWO POINTS WITHIN A SINGLE COUNTY;
2	OR
3	(II) BETWEEN A POINT IN ONE COUNTY AND ANOTHER
4	POINT IN THE STATE WITHIN 40 MILES OF THAT COUNTY.
5	(2) A LOCAL EXCHANGE TELEPHONE SERVICE PROVIDER MAY
6	NOT BILL ANY TELEPHONE CALL THAT IS TOLL FREE UNDER PARAGRAPH (1) OF
7	THIS SUBSECTION SEPARATELY FROM THE MONTHLY LOCAL TELEPHONE
8	SERVICE CHARGE FOR THE LINE FROM WHICH THE CALL IS MADE.
9	(C) THIS SECTION MAY NOT BE CONSTRUED TO LIMIT, TO INCREASE
10	RATES FOR, OR OTHERWISE TO INTERFERE WITH TELEPHONE SERVICE
11	PROVIDED TO CUSTOMERS UNDER A FOREIGN EXCHANGE TELEPHONE LINE
