BY repealing and reenacting, with amendments, Article – Labor and Employment Section 3-305 Annotated Code of Maryland (1999 Replacement Volume and 2007 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Labor and Employment 3 - 305. [(1)] Each employer shall keep each record that the Commissioner (a) requires on: [(i)] **(1)** wages of employees;
