BY repealing and reenacting, without amendments, Article – Public Utility Companies Section 7-701(g)Annotated Code of Maryland (1998 Volume and 2007 Supplement) BY repealing and reenacting, with amendments, Article – Public Utility Companies Section 7-701(1) and (m) and 7-704(a)(4)
