1 AN ACT concerning

2 Criminal Law – Impersonation of a Police Officer – Penalties

- FOR the purpose of altering the classification of the crime of impersonating certain 3 police officers, special police officers, sheriffs, deputy sheriffs, constables, or 4 certain other law enforcement officers wearing a certain police article without a 5 certain authorization, or having a simulation or imitation of a certain police 6 article under certain circumstances from a misdemeanor to a felony and 7 increasing the penalties for a violation of the offense; and generally relating to 8 9 the crime of impersonating police officers, special police officers, sheriffs, deputy sheriffs, constables, or certain other law enforcement officers. 10
