## A BILL ENTITLED

1 AN ACT concerning

2 **Credit Regulation – Debt Settlement and Debt Management Services**  
3 **Providers**

4 FOR the purpose of prohibiting a person from providing debt settlement services to  
5 certain consumers unless the person is licensed by the Commissioner of  
6 Financial Regulation or exempt from licensing under the Maryland Debt  
7 Management and Debt Settlement Services Act; altering a certain exemption  
8 from certain provisions of law; applying certain provisions of law relating to  
9 debt management services, debt management services businesses, and debt  
10 management services providers, licensees, and agreements to debt settlement  
11 services, debt settlement services businesses, and debt settlement services  
12 providers, licensees, and agreements; altering the name, contents, and purpose  
13 of a certain fund; providing that a debt settlement services license authorizes  
14 the licensee to provide debt settlement services; requiring a person who  
15 provides both debt management services and debt settlement services to obtain  
16 both a debt management services license and a debt settlement services license;  
17 specifying the information a licensee who provides debt settlement services  
18 must provide to the Commissioner if the licensee surrenders its license;  
19 prohibiting a licensee from performing debt settlement services for a consumer  
20 unless certain conditions are met; establishing certain requirements for a debt  
21 settlement services agreement; requiring a debt settlement services licensee to  
22 maintain certain records; authorizing a debt settlement services licensee to  
23 allow a consumer to establish a certain account under certain circumstances;  
24 prohibiting a debt settlement services provider from paying any funds from  
25 certain accounts without the express written authorization of the consumer;  
26 prohibiting a debt settlement services licensee from imposing certain fees or  
27 other charges or receiving any funds, voluntary contributions, or other  
28 payments except under certain circumstances; requiring a debt settlement  
29 services licensee to disclose certain services and charges to a consumer;  
30 establishing the right of a consumer to modify or rescind a debt settlement  
31 services agreement under certain circumstances; providing that a debt

1 settlement services agreement shall be void and the debt settlement services  
 2 licensee shall return certain fees, charges, funds, and payments to a consumer  
 3 under certain circumstances; prohibiting a debt settlement services licensee  
 4 from making a certain representation relating to a consumer's debt; prohibiting  
 5 a debt settlement services licensee from requiring or advising a consumer to  
 6 stop making certain payments; requiring a debt management services licensee  
 7 and a debt settlement services licensee to file a certain report with the  
 8 Commissioner if a certain legal proceeding is instituted against the licensee;  
 9 requiring the Commissioner to examine the business of each debt management  
 10 services licensee and each debt settlement services licensee in accordance with a  
 11 certain schedule; altering a certain short title; altering certain definitions;  
 12 defining certain terms; making certain stylistic, clarifying, and conforming  
 13 changes; allowing certain persons providing debt settlement services in the  
 14 State on the effective date of this Act to continue to provide debt settlement  
 15 services without being licensed until a certain time under certain  
 16 circumstances; and generally relating to the regulation of debt management  
 17 services providers and debt settlement services providers.

31 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 32 MARYLAND, That the Laws of Maryland read as follows:

33 **Article – Financial Institutions**

34 Subtitle 9. Maryland Debt Management **AND DEBT SETTLEMENT** Services Act.

35 12–901.

36 (a) In this subtitle the following words have the meanings indicated.

37 (b) “Annual gross revenue” means income or revenue from all sources, before  
 38 any expenses or taxes, computed according to generally accepted accounting principles  
 39 for the preceding fiscal year.

1 (c) "Consultation fee" means a fee paid by a consumer to:

2 (1) [a] A debt management services provider in connection with the  
3 processing of any application that the consumer makes for debt management services;  
4 **OR**

5 (2) **A DEBT SETTLEMENT SERVICES PROVIDER IN CONNECTION**  
6 **WITH THE PROCESSING OF ANY APPLICATION THAT THE CONSUMER MAKES FOR**  
7 **DEBT SETTLEMENT SERVICES.**

8 (d) "Consumer" means an individual who:

9 (1) Resides in the State; and

10 (2) (I) Is seeking debt management services or has entered into a  
11 debt management services agreement; **OR**

12 (II) **IS SEEKING DEBT SETTLEMENT SERVICES OR HAS**  
13 **ENTERED INTO A DEBT SETTLEMENT SERVICES AGREEMENT.**

14 (e) "Consumer education program" means a program or plan that seeks to  
15 improve the financial literacy of consumers.

16 (f) "Debt management counselor" means a permanent, temporary, or  
17 contractual employee of a debt management services provider or its agent who  
18 provides counseling to consumers on behalf of the debt management services provider.

19 (g) "Debt management services" means receiving funds periodically from a  
20 consumer under an agreement with the consumer for the purpose of distributing the  
21 funds among the consumer's creditors in full or partial payment of the consumer's  
22 debts.

23 (h) "Debt management services agreement" means a written contract, plan,  
24 or agreement between a debt management services provider and a consumer for the  
25 performance of debt management services.

26 (i) "Debt management services provider" means an organization that  
27 provides or offers to provide debt management services to a consumer.

28 (J) **"DEBT SETTLEMENT COUNSELOR" MEANS A PERMANENT,**  
29 **TEMPORARY, OR CONTRACTUAL EMPLOYEE OF A DEBT SETTLEMENT SERVICES**  
30 **PROVIDER OR ITS AGENT WHO PROVIDES COUNSELING TO CONSUMERS ON**  
31 **BEHALF OF THE DEBT SETTLEMENT SERVICES PROVIDER.**

1           **(K) “DEBT SETTLEMENT SERVICES FEE” MEANS A FEE EARNED BY A**  
2 **DEBT SETTLEMENT SERVICES PROVIDER FOR PERFORMING DEBT SETTLEMENT**  
3 **SERVICES FOR A CONSUMER.**

4           **(L) (1) “DEBT SETTLEMENT SERVICES” MEANS ACTING OR OFFERING**  
5 **OR ATTEMPTING TO ACT FOR CONSIDERATION AS AN INTERMEDIARY BETWEEN**  
6 **A CONSUMER AND THE CONSUMER’S CREDITORS FOR THE PURPOSE OF**  
7 **SETTLING OR IN ANY WAY ALTERING THE TERMS OF PAYMENT OF ANY DEBT.**

8           **(2) “DEBT SETTLEMENT SERVICES” DOES NOT INCLUDE DEBT**  
9 **MANAGEMENT SERVICES.**

10           **(M) “DEBT SETTLEMENT SERVICES AGREEMENT” MEANS A WRITTEN**  
11 **CONTRACT, PLAN, OR AGREEMENT BETWEEN A DEBT SETTLEMENT SERVICES**  
12 **PROVIDER AND A CONSUMER FOR THE PERFORMANCE OF DEBT SETTLEMENT**  
13 **SERVICES.**

14           **(N) “DEBT SETTLEMENT SERVICES PROVIDER” MEANS A PERSON THAT**  
15 **PROVIDES OR OFFERS TO PROVIDE DEBT SETTLEMENT SERVICES TO A**  
16 **CONSUMER.**

17           **[(j)] (O) “Fund” means the Debt Management AND SETTLEMENT Services**  
18 **Fund established under § 12–905 of this subtitle.**

19           **[(k)] (P) “Licensee” means:**

20                           **(1) [an] AN organization licensed under this subtitle to provide**  
21 **debt management services; OR**

22                           **(2) A PERSON LICENSED UNDER THIS SUBTITLE TO**  
23 **PROVIDE DEBT SETTLEMENT SERVICES.**

24           **[(l)] (Q) “Maintenance fee” means a fee paid by a consumer to a debt**  
25 **management services provider for the maintenance or servicing of the consumer’s**  
26 **accounts with the consumer’s creditors in accordance with a debt management**  
27 **services agreement.**

28           **[(m)] (R) “Organization” means a nonprofit organization that is exempt from**  
29 **taxation under § 501(c) of the Internal Revenue Code.**

30           **[(n)] (S) “Relative” means any of the following who are related to an**  
31 **individual by blood, marriage, or adoption:**

32                           **(1) A spouse;**

- 1 (2) A child;
- 2 (3) A sibling;
- 3 (4) A parent;
- 4 (5) A grandparent;
- 5 (6) A grandchild;
- 6 (7) A stepparent;
- 7 (8) A stepchild;
- 8 (9) A stepsibling;
- 9 (10) An aunt; or
- 10 (11) An uncle.

11 [(o)] (T) “Resident agent” means an individual residing in the State or a  
 12 Maryland corporation whose name, address, and designation as a resident agent are  
 13 filed or recorded with the State Department of Assessments and Taxation in  
 14 accordance with the provisions of the Corporations and Associations Article.

15 [(p)] (U) “Trust account” means an account that is:

- 16 (1) Established in a financial institution that is federally insured;
- 17 (2) Separate from the debt management services provider’s **OR DEBT**  
 18 **SETTLEMENT SERVICES PROVIDER’S** operating account;
- 19 (3) Designated as a “trust account” or by another appropriate  
 20 designation indicating that the funds in the account are not the funds of the licensee  
 21 or its officers, employees, or agents;
- 22 (4) Unavailable to creditors of the debt management services provider  
 23 **OR THE DEBT SETTLEMENT SERVICES PROVIDER**; and
- 24 (5) Used to hold funds paid by consumers:

25 (I) [to] **TO** a debt management services provider for  
 26 disbursement to creditors of the consumers; **OR**

27 (II) **DIRECTLY INTO THE ACCOUNT IN ACCORDANCE WITH A**  
 28 **DEBT SETTLEMENT SERVICES AGREEMENT.**

1 12-902.

2 This subtitle does not apply to:

3 (1) The following persons when engaged in the regular course of their  
4 respective businesses and professions:

5 (i) An attorney at law **WHO IS ADMITTED TO PRACTICE IN**  
6 **THE STATE AND IS NOT PRINCIPALLY ENGAGED AS A DEBT MANAGEMENT**  
7 **SERVICES PROVIDER OR A DEBT SETTLEMENT SERVICES PROVIDER;**

8 (ii) An escrow agent;

9 (iii) A certified public accountant;

10 (iv) A banking institution, other—state bank, national banking  
11 association, credit union, or savings and loan association;

12 (v) A person that:

13 1. Provides bill payer services, as defined in § 12-401 of  
14 this title;

15 2. Does not initiate any contract with individual  
16 creditors of the debtor to compromise a debt or arrange a new payment schedule; and

17 3. Does not provide any debt counseling services;

18 (vi) A person that provides accelerated mortgage payment  
19 services, as defined in § 12-401 of this title;

20 (vii) A title insurer, title insurance agency, or abstract company;  
21 or

22 (viii) A judicial officer or a person acting under a court order;

23 (2) A person while performing services incidental to the dissolution,  
24 winding up, or liquidation of a partnership, corporation, or other business enterprise;

25 (3) A trade or mercantile association acting in the course of arranging  
26 the adjustment of debts with a business establishment; or

27 (4) A mortgage lender, as defined in § 11-501 of this article, that:

28 (i) Is licensed by the Commissioner; and

1 (ii) Does not receive funds from a consumer for the purpose of  
2 distributing the funds among the consumer's creditors in full or partial payment of the  
3 consumer's debts.

4 12-903.

5 To carry out the provisions of this subtitle, the Commissioner may:

6 (1) Adopt rules and regulations;

7 (2) Enter into cooperative and information sharing agreements with  
8 any other federal or State agencies having supervisory responsibility over debt  
9 management services businesses **OR DEBT SETTLEMENT SERVICES BUSINESSES;**  
10 and

11 (3) Exchange information about a debt management services provider  
12 **OR A DEBT SETTLEMENT SERVICES PROVIDER**, including information obtained  
13 during an examination, with any State or federal agency having authority over the  
14 debt management services provider **OR DEBT SETTLEMENT SERVICES PROVIDER.**

15 12-904.

16 The Commissioner shall charge:

17 (1) (i) A fee for the issuance of an initial license under this subtitle  
18 in an even-numbered year as follows:

19 1. \$1,000, if the applicant's annual gross revenue is not  
20 more than \$3,000,000;

21 2. \$2,000, if the applicant's annual gross revenue is more  
22 than \$3,000,000 but not more than \$6,000,000;

23 3. \$4,000, if the applicant's annual gross revenue is more  
24 than \$6,000,000 but not more than \$15,000,000;

25 4. \$6,000, if the applicant's annual gross revenue is more  
26 than \$15,000,000 but not more than \$30,000,000; or

27 5. \$8,000, if the applicant's annual gross revenue is more  
28 than \$30,000,000; and

29 (ii) A fee for the issuance of an initial license under this subtitle  
30 in an odd-numbered year as follows:

31 1. \$500, if the applicant's annual gross revenue is not  
32 more than \$3,000,000;

1                                   2.     \$1,000, if the applicant's annual gross revenue is more  
2 than \$3,000,000 but not more than \$6,000,000;

3                                   3.     \$2,000, if the applicant's annual gross revenue is more  
4 than \$6,000,000 but not more than \$15,000,000;

5                                   4.     \$3,000, if the applicant's annual gross revenue is more  
6 than \$15,000,000 but not more than \$30,000,000; or

7                                   5.     \$4,000, if the applicant's annual gross revenue is more  
8 than \$30,000,000;

9                   (2)     A fee for renewal of a license issued under this subtitle as follows:

10                                   (i)     \$1,000, if the applicant's annual gross revenue is not more  
11 than \$3,000,000;

12                                   (ii)    \$2,000, if the applicant's annual gross revenue is more than  
13 \$3,000,000 but not more than \$6,000,000;

14                                   (iii)   \$4,000, if the applicant's annual gross revenue is more than  
15 \$6,000,000 but not more than \$15,000,000;

16                                   (iv)    \$6,000, if the applicant's annual gross revenue is more than  
17 \$15,000,000 but not more than \$30,000,000; or

18                                   (v)     \$8,000, if the applicant's annual gross revenue is more than  
19 \$30,000,000;

20                   (3)     A fee of \$100, for each location in the State at which a licensee  
21 provides debt management services **OR DEBT SETTLEMENT SERVICES** under this  
22 subtitle, payable at the time of application for an initial license and at each renewal of  
23 a license; and

24                   (4)     A fee of \$1,000, for an investigation of an applicant under this  
25 subtitle, payable at the time of application for an initial license.

26 12-905.

27                   (a)     There is a Debt Management **AND SETTLEMENT** Services Fund that  
28 consists of:

29                                   (1)     All revenue received for the licensing of organizations that provide  
30 debt management services **AND PERSONS THAT PROVIDE DEBT SETTLEMENT**  
31 **SERVICES** under this subtitle;



1                   (2)     Income from investments that the Treasurer makes for the Fund;  
2     and

3                   (3)     Except as provided in subsection (b) of this section, any other fee or  
4     revenue received by the Commissioner under this subtitle.

5                   (b)     The Commissioner shall pay all fines and penalties collected by the  
6     Commissioner under this subtitle into the General Fund of the State.

7                   (c)     The purpose of the Fund is to pay all the costs and expenses incurred by  
8     the Commissioner that are related to the regulation of the debt management services  
9     business **AND THE DEBT SETTLEMENT SERVICES BUSINESS** under this subtitle,  
10    including:

11                   (1)     Expenditures authorized under this subtitle; and

12                   (2)     Any other expense authorized in the State budget.

13                   (d)     (1)     The Treasurer is the custodian of the Fund.

14                                 (2)     The Treasurer shall deposit payments received from the  
15     Commissioner into the Fund.

16                   (e)     (1)     The Fund is a continuing, nonlapsing fund that is not subject to §  
17     7-302 of the State Finance and Procurement Article, and may not be deemed a part of  
18     the General Fund of the State.

19                                 (2)     Unless otherwise provided by law, no part of the Fund may revert  
20     or be credited to:

21   (i)     The General Fund of the State; or

22   (ii)    A special fund of the State.

23                   (f)     (1)     All the costs and expenses of the Commissioner relating to the  
24     regulation of the debt management services business **AND THE DEBT SETTLEMENT**  
25     **SERVICES BUSINESS** under this subtitle shall be included in the State budget.

26                                 (2)     Any expenditures from the Fund to cover costs and expenses of the  
27     Commissioner may be made only:

28   (i)     By an appropriation from the Fund approved by the General  
29     Assembly in the annual State budget; or

30   (ii)    By the budget amendment procedure provided for in § 7-209  
31     of the State Finance and Procurement Article.

1 (3) If, in any fiscal year, the amount of the revenue collected by the  
2 Commissioner and deposited into the Fund exceeds the actual appropriation for the  
3 Commissioner to regulate the debt management services business **AND THE DEBT**  
4 **SETTLEMENT SERVICES BUSINESS** under this subtitle, the excess amount shall be  
5 carried forward within the Fund.

6 (g) The Office of Legislative Audits shall audit the accounts and transactions  
7 of the Fund under § 2–1220 of the State Government Article.

8 12–906.

9 Whether or not the person maintains an office in this State, a person may not  
10 provide debt management services **OR DEBT SETTLEMENT SERVICES** to consumers  
11 unless the person:

12 (1) Is licensed by the Commissioner under this subtitle; or

13 (2) Is exempt from licensing under this subtitle.

14 12–907.

15 (a) To qualify for a license, an applicant shall satisfy the Commissioner that:

16 (1) [The] **IF THE APPLICANT PROVIDES DEBT MANAGEMENT**  
17 **SERVICES, THE** applicant is an organization;

18 (2) Each of the owners, officers, directors, and principals of the  
19 applicant has sufficient experience, character, financial responsibility, and general  
20 fitness to:

21 (i) Engage in the business of providing debt management  
22 services **OR DEBT SETTLEMENT SERVICES**;

23 (ii) Warrant the belief that the debt management services  
24 business **OR THE DEBT SETTLEMENT SERVICES BUSINESS** will be conducted  
25 lawfully, honestly, fairly, and efficiently; and

26 (iii) Command the confidence of the public;

27 (3) Each agent acting on behalf of the applicant to manage a trust  
28 account required under § 12–917 of this subtitle has sufficient experience, character,  
29 financial responsibility, and general fitness to:

30 (i) Engage in the business of managing a trust account;

31 (ii) Warrant the belief that the management of the trust account  
32 will be conducted lawfully, honestly, fairly, and efficiently; and

1 (iii) Command the confidence of the public; and

2 (4) The applicant has a net worth computed according to generally  
3 accepted accounting principles of at least \$50,000, plus an additional net worth of  
4 \$10,000 for each location at which debt management services **OR DEBT SETTLEMENT**  
5 **SERVICES** will be provided to consumers, up to a maximum of \$500,000 as provided in  
6 subsection (b) of this section.

7 (b) The Commissioner may require a net worth of up to \$500,000, subject to a  
8 consideration of the following:

9 (1) The nature and volume of the business or proposed business of the  
10 applicant;

11 (2) The amount, nature, quality, and liquidity of the assets of the  
12 applicant;

13 (3) The amount and nature of the liabilities, including contingent  
14 liabilities, of the applicant;

15 (4) The history of and prospects for the applicant to earn and retain  
16 income;

17 (5) The quality of the operations of the applicant;

18 (6) The quality of the management of the applicant;

19 (7) The nature and quality of the person that has control of the  
20 applicant; and

21 (8) Any other factor that the Commissioner considers relevant.

22 12-908.

23 (a) To apply for a license, an applicant shall submit to the Commissioner an  
24 application on the form that the Commissioner provides.

25 (b) The application shall include:

26 (1) The applicant's name, business address, telephone number,  
27 electronic mail address, if any, and website address, if any;

28 (2) The address of each location in the State at which the applicant  
29 will provide debt management services **OR DEBT SETTLEMENT SERVICES**;

1 (3) The name and address of each owner, officer, director, and  
2 principal of the applicant;

3 (4) The name, address, and telephone number of the applicant's  
4 resident agent in the State;

5 (5) A description of the ownership interest of any officer, director,  
6 agent, or employee of the applicant in any affiliate or subsidiary of the applicant or in  
7 any other business entity that provides any service to the applicant or any consumer  
8 relating to the applicant's debt management services business **OR DEBT**  
9 **SETTLEMENT SERVICES BUSINESS;**

10 (6) The name and address of any agent acting on behalf of the  
11 applicant to manage a trust account required under § 12-917 of this subtitle;

12 (7) The applicant's federal employer identification number;

13 (8) A list of any state in which:

14 (i) The applicant engages in the business of providing debt  
15 management services **OR DEBT SETTLEMENT SERVICES;**

16 (ii) The applicant is registered or licensed to provide debt  
17 management services **OR DEBT SETTLEMENT SERVICES;** and

18 (iii) The applicant's registration or license has been suspended or  
19 revoked;

20 (9) A statement of whether any pending judgment, tax lien, material  
21 litigation, or administrative action by any government agency exists against the  
22 applicant;

23 (10) The most recent, unconsolidated financial statement of the  
24 applicant that:

25 (i) Is prepared in accordance with generally accepted  
26 accounting principles applied on a consistent basis;

27 (ii) Includes a certified opinion audit prepared by an  
28 independent certified public accountant; and

29 (iii) Was prepared no more than 12 months before the date of  
30 application;

31 (11) [Evidence] **IF THE APPLICANT PROVIDES DEBT MANAGEMENT**  
32 **SERVICE, EVIDENCE** of nonprofit status under § 501(c) of the Internal Revenue Code;

1 (12) If the applicant is a corporation, a detailed description of the  
2 applicant's corporate structure, including parent companies, subsidiaries, and  
3 affiliates;

4 (13) The applicant's business credit report;

5 (14) Evidence of general liability or fidelity insurance that insures  
6 against dishonesty, fraud, theft, or other malfeasance on the part of an employee of the  
7 applicant;

8 (15) A description of the applicant's consumer education program that  
9 is provided to consumers;

10 (16) A description of the applicant's financial analysis and initial  
11 budget plan, including any form or electronic model, that are used to evaluate the  
12 financial condition of consumers;

13 (17) **(I)** A copy of the debt management services agreement that the  
14 applicant will use in its debt management services business; **OR**

15 **(II) A COPY OF THE DEBT SETTLEMENT SERVICES**  
16 **AGREEMENT THAT THE APPLICANT WILL USE IN ITS DEBT SETTLEMENT**  
17 **SERVICES BUSINESS;**

18 (18) A copy of the applicant's plan to ensure that each debt  
19 management counselor **OR DEBT SETTLEMENT COUNSELOR** is certified by an  
20 independent organization within 6 months after the debt management counselor **OR**  
21 **DEBT SETTLEMENT COUNSELOR** is hired, and that any employee who is a supervisor  
22 or manager of a debt management counselor **OR DEBT SETTLEMENT COUNSELOR** is  
23 certified by an independent organization within 3 months after the employee is hired;

24 (19) The most recent financial statement of each affiliate, subsidiary, or  
25 other person that provides services related to debt management services **OR DEBT**  
26 **SETTLEMENT SERVICES** for the applicant or for any consumer;

27 (20) A copy of each contract or fee-for-service arrangement between  
28 the applicant and any person that provides services related to the debt management  
29 services business **OR THE DEBT SETTLEMENT SERVICES BUSINESS;** and

30 (21) Any other information that the Commissioner reasonably requires.

31 (c) The Commissioner may refuse an application if it contains erroneous or  
32 incomplete information.

33 (d) With the application, the applicant shall pay to the Commissioner:

1 (1) A license fee in the amount established under § 12-904 of this  
2 subtitle; and

3 (2) A nonrefundable investigation fee in the amount established under  
4 § 12-904 of this subtitle.

5 (e) With the application, the applicant shall file a surety bond with the  
6 Commissioner as provided in § 12-914 of this subtitle.

7 12-911.

8 (a) The Commissioner shall include on each license:

9 (1) The name of the licensee;

10 (2) The address at which the business is to be conducted; and

11 (3) The debt management services **OR DEBT SETTLEMENT SERVICES**

28 licensee:

29 (1) Fraudulently or deceptively obtains or attempts to obtain a license;

30 (2) Fraudulently or deceptively uses a license or debt management  
31 services **OR DEBT SETTLEMENT SERVICES** license number;

32 (3) Presents or attempts to present the debt management services **OR**  
33 **DEBT SETTLEMENT SERVICES** license number of another licensee as the applicant's

1 or licensee's debt management services **OR DEBT SETTLEMENT SERVICES** license  
2 number;

3 (4) Violates any provision of this subtitle or any regulation adopted  
4 under this subtitle;

5 (5) Is convicted under the laws of the United States or of any state of:

6 (i) A felony; or

7 (ii) A misdemeanor that is directly related to the fitness and  
8 qualification of the applicant or licensee to engage in the business of providing debt  
9 management services **OR DEBT SETTLEMENT SERVICES**;

10 (6) In connection with the provision of debt management services **OR**  
11 **DEBT SETTLEMENT SERVICES**:

12 (i) Commits a fraud;

13 (ii) Engages in an illegal or dishonest activity;

14 (iii) Has engaged or participated in an unsafe or unsound act; or

15 (iv) Misrepresents or fails to disclose a material fact to a person  
16 entitled to that information;

17 (7) Engages in false, misleading, or deceptive advertising; or

18 (8) Otherwise demonstrates unworthiness, bad faith, dishonesty, or  
19 any other quality that indicates that the business of the applicant or licensee has not  
20 been or will not be conducted honestly, fairly, and equitably.

21 (b) In determining whether to deny a license to an applicant, reprimand a  
22 licensee, or suspend or revoke the license of a licensee for a reason listed in subsection  
23 (a)(5) of this section, the Commissioner shall consider:

24 (1) The nature of the crime;

25 (2) The relationship of the crime to the activities authorized by the  
26 license;

27 (3) With respect to a felony, the relevance of the conviction to the  
28 fitness and qualification of the applicant or licensee to provide debt management  
29 services **OR DEBT SETTLEMENT SERVICES**;

30 (4) The length of time since the conviction; and

1           (5)    The behavior and activities of the applicant or licensee since the  
2 conviction.

3           (c)    Subject to the hearing provisions of § 12-927 of this subtitle, the  
4 Commissioner shall deny a license to an applicant and suspend or revoke the license of  
5 a licensee if the applicant or licensee or an owner, officer, director, or principal of the  
6 applicant or licensee has:

7           (1)    Committed a violation of subsection (a) of this section that directly  
8 results in property damage or monetary loss by any other person; and

9           (2)    Has not restored the property or money to the person or paid the  
10 value of the property to the person.

12           This subtitle may be cited as the Maryland Debt Management **AND DEBT**  
13 **SETTLEMENT** Services Act.

14           SECTION 2. AND BE IT FURTHER ENACTED, That in the absence of an  
15 order by the Commissioner of Financial Regulation to the contrary, a person providing  
16 debt settlement services to Maryland consumers on the effective date of this Act may  
17 continue to provide debt settlement services to Maryland consumers without being  
18 licensed, as required under Section 1 of this Act, until the Commissioner approves or  
19 disapproves the person's application for a license if:

20           (a)    the person applies for a license no later than 30 days after the date the  
21 Commissioner makes license applications available; and

22           (b)    the person complies with all other provisions of the Maryland Debt  
23 Management and Debt Settlement Services Act, as enacted by Section 1 of this Act.

24           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2008.
