## A BILL ENTITLED

## 1 AN ACT concerning

## Horse Racing Heritage Act

3 FOR the purpose of establishing a special fund for the distribution of certain State 4 lottery revenues to horse racing purses and bred funds; requiring that horse 5 racing purses and bred funds be increased according to a certain formula; 6 authorizing the Governor to request a certain deficiency appropriation under 7 certain conditions; requiring that all funds for purses and bred funds under this 8 Act be in addition to and not supplant certain other funds; establishing certain 9 conditions on the distribution of certain funds; and generally relating to lottery 10 proceeds and purse and bred fund supplements for horse racing in the State.

 $\mathbf{5}$ (A) NOTWITHSTANDING § 9–120 OF AFTER THIS SUBTITLE, 6 CUMULATIVE DISTRIBUTIONS FOR FISCAL YEAR 2008 TO THE GENERAL FUND 7 UNDER § 9-120(B)(1)(III) OF THIS SUBTITLE TOTAL \$473,100,000, \$6,000,000 8 OF THE REMAINING REVENUE THAT WOULD OTHERWISE BE PAID TO THE 9 GENERAL FUND UNDER § 9-120(B)(1)(III) OF THIS SUBTITLE SHALL BE 10 DISTRIBUTED TO THE SPECIAL FUND UNDER § 9–120(B)(1)(II) OF THIS 11 SUBTITLE TO BE USED ONLY TO INCREASE PURSES AT HARNESS RACING 12TRACKS, MILE THOROUGHBRED TRACKS, AND TIMONIUM RACE COURSE AND TO 13 SUPPLEMENT EXISTING BRED FUNDS.

(B) IF LOTTERY REVENUES DO NOT PROVIDE THE \$6,000,000 FOR THE

 MAY REQUEST A DEFICIENCY APPROPRIATION DURING THE 2009 LEGISLATIVE
 SESSION TO MAKE UP THE DIFFERENCE.

18 (C) IN ACCORDANCE WITH § 7–209 OF THE STATE FINANCE AND 19 PROCUREMENT ARTICLE, THE GOVERNOR BY BUDGETARY AMENDMENT SHALL 20 ALLOCATE MONEY FROM THE SPECIAL FUND UNDER § 9–120(B)(1)(II) OF THIS 21 SUBTITLE IN THE MANNER SPECIFIED UNDER SUBSECTION (D) OF THIS 22 SECTION.

23(D) ANY AMOUNTS CREDITED TO THE SPECIAL FUND UNDER24SUBSECTION (A) OF THIS SECTION OR UNDER § 9–120(B)(1)(II) OF THIS25SUBTITLE SHALL BE USED AS FOLLOWS:

26(1)11% TO INCREASE THE BRED FUNDS TO BE ALLOCATED AS27FOLLOWS:

- (I) 80% TO THE MARYLAND-BRED RACE FUND; AND
  (II) 20% TO THE MARYLAND STANDARDBRED RACE FUND;
  (II) 20% TO THE MARYLAND STANDARDBRED RACE FUND;
  (I) 89% TO INCREASE PURSES AT HARNESS RACING TRACKS AND
  (I) 80% TO PURSES AT THE MILE THOROUGHBRED RACING
  - (I) 80% TO PURSES AT THE MILE THOROUGHBRED RACING
     TRACKS AND TIMONIUM RACE COURSE; AND

1 (II) 20% TO PURSES AT THE HARNESS RACING TRACKS, 2 WHICH SHALL BE ALLOCATED 85% FOR ROSECROFT RACEWAY AND 15% FOR 3 OCEAN DOWNS RACETRACK.

4 (E) FOR EACH RACETRACK LICENSEE, FUNDS PROVIDED FOR PURSES 5 AND BRED FUNDS MAY ONLY BE ALLOCATED IF THE MARYLAND RACING 6 COMMISSION HAS AWARDED AT LEAST THE SAME NUMBER OF LIVE RACING 7 DAYS FOR EACH RACETRACK FOR CALENDAR YEAR 2008 AS WERE RUN IN 8 CALENDAR YEAR 2007.

9 (F) ALL FUNDS PROVIDED FOR PURSES AND BRED FUNDS AT HARNESS 10 RACING TRACKS, MILE THOROUGHBRED RACING TRACKS, AND TIMONIUM RACE 11 COURSE BY THIS SECTION SHALL BE IN ADDITION TO AND MAY NOT SUPPLANT:

12(1) AMOUNTS ALLOCATED FOR PURSES AND BRED FUNDS UNDER13CURRENT AGREEMENTS BETWEEN THE HARNESS RACING TRACKS AND THE14ORGANIZATION THAT REPRESENTS A MAJORITY OF OWNERS AND TRAINERS OF15STANDARDBRED HORSES IN THE STATE; AND

16(2) AMOUNTS OTHERWISE PROVIDED IN STATUTE FOR PURSES17AND BRED FUNDS AT MILE THOROUGHBRED RACING TRACKS AND TIMONIUM18RACE COURSE.

19(G) THE PURSES SHALL BE DISTRIBUTED AT MILE THOROUGHBRED20RACETRACKS AND TIMONIUM RACE COURSE ACCORDING TO A FORMULA21DETERMINED BY THE STATE RACING COMMISSION IN CONSULTATION WITH THE22RACETRACK LICENSEES AND THE ORGANIZATION THAT REPRESENTS A23MAJORITY OF OWNERS AND TRAINERS OF THOROUGHBRED HORSES IN THE24STATE.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
