A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Energy Administration – Maryland Clean Energy Center**

3 FOR the purpose of establishing a Maryland Clean Energy Center in the State;
4 providing for the powers, purposes, and duties of the Center; establishing a
5 Board of Directors of the Center, with certain membership, powers, duties, and
6 officers; providing for the staffing of the Center, including appointment of an
7 Executive Director with certain duties; providing that the Attorney General is
8 the legal advisor of the Center; providing for the application of certain laws to
9 the Center; providing for the effect of a certain determination of the Board;
10 requiring the establishment of certain financial controls for the Center;
11 authorizing the Center to exercise certain powers, including those relating to
12 grants, projects, and borrowing; requiring the Center to act as a clearinghouse
13 of information regarding clean energy for certain purposes; establishing a
14 Maryland Clean Energy Fund as a special, nonlapsing fund from certain
15 sources and for certain purposes; exempting the Center from certain taxes;
16 providing that the books and records of the Center are subject to audit in a
17 certain manner; requiring the Center to report each year to certain persons;
18 establishing a Maryland Clean Energy Technology Incubator Program in the
19 Center for certain purposes; requiring the Center to adopt certain standards for
20 the Program in a certain manner; authorizing the Center to award certain
21 financial assistance to certain entities; requiring matching contributions for
22 certain assistance; authorizing the Center to issue bonds and other evidences of
23 indebtedness in certain manners; authorizing the Center to authorize certain
24 persons to take certain actions regarding bond issuance for certain purposes,
25 subject to certain limitations; providing for the contents of a certain trust
26 agreement for certain purposes; authorizing the pledging of certain revenues for
27 certain purposes in a certain manner; authorizing certain persons to invest in
28 certain bonds; providing that certain bonds are not a debt or liability or a pledge
29 of the faith and credit of the State or of a political subdivision; authorizing the
30 Center to fix and collect certain rates, rents, fees, and charges for certain
31 purposes; providing for the application of certain proceeds; authorizing the

1 issuance of certain refunding bonds in a certain manner; authorizing the
 2 issuance of certain negotiable bond anticipation notes for certain purposes in a
 3 certain manner; providing for the enforcement of certain rights by certain
 4 persons; providing that certain projects, property, and bonds are exempt from
 5 certain taxes under certain circumstances; stating findings and intent of the
 6 General Assembly; defining certain terms; providing for the construction of this
 7 Act; and generally relating to the Maryland Clean Energy Center.

18 (II) **ACQUIRING AND IMPROVING A PROJECT; AND**

19 (III) **PLACING A PROJECT IN OPERATION.**

20 (H) **“DIRECTOR” MEANS THE DIRECTOR OF THE ADMINISTRATION.**

21 (I) **“EXECUTIVE DIRECTOR” MEANS THE EXECUTIVE DIRECTOR OF**
22 **THE MARYLAND CLEAN ENERGY CENTER.**

23 (J) **“FINANCE” INCLUDES REFINANCE.**

24 (K) **“FUND” MEANS THE MARYLAND CLEAN ENERGY FUND**
25 **ESTABLISHED UNDER § 10-824 OF THIS SUBTITLE.**

26 (L) **“IMPROVE” MEANS TO ADD, ALTER, CONSTRUCT, EQUIP, EXPAND,**

4 (N) **“GOVERNMENTAL UNIT” MEANS:**

5 (1) **A COUNTY;**

6 (2) **A MUNICIPAL CORPORATION;**

7 (3) **A STATE UNIT;**

8 (4) **A LOCAL UNIT; OR**

9 (5) **ANY OTHER PUBLIC BODY OR UNIT ESTABLISHED IN**
10 **ACCORDANCE WITH A STATE OR LOCAL LAW, ORDINANCE, OR RESOLUTION.**

11 (O) (1) **“PROJECT” MEANS ANY PROPERTY, THE ACQUISITION OR**
12 **IMPROVEMENT OF WHICH THE BOARD, IN ITS SOLE DISCRETION, DETERMINES**
13 **BY RESOLUTION WILL ACCOMPLISH AT LEAST ONE OF THE PURPOSES LISTED IN**
14 **§ 10-802(B) OF THIS SUBTITLE, WHETHER OR NOT THE PROPERTY:**

15 (I) **IS OR WILL BE USED OR OPERATED FOR PROFIT OR NOT**
16 **FOR PROFIT;**

17 (II) **IS OR WILL BE LOCATED ON A SINGLE SITE OR**
18 **MULTIPLE SITES; OR**

19 (III) **MAY BE FINANCED BY BONDS, THE INTEREST ON WHICH**
20 **IS EXEMPT FROM INCOME TAXATION UNDER FEDERAL LAW.**

21 (2) **“PROJECT” INCLUDES:**

22 (I) **LAND OR AN INTEREST IN LAND;**

23 (II) **STRUCTURES, EQUIPMENT, FURNISHINGS, RAIL OR**
24 **MOTOR VEHICLES, BARGES, AND BOATS;**

25 (III) **PROPERTY AND RIGHTS RELATED TO PROPERTY,**
26 **APPURTENANCES, RIGHTS-OF-WAY, FRANCHISES, AND EASEMENTS;**

27 (IV) **PROPERTY THAT IS FUNCTIONALLY RELATED AND**
28 **SUBORDINATE TO A PROJECT; AND**

1 (V) PATENTS, LICENSES, AND OTHER RIGHTS NECESSARY
2 OR USEFUL IN THE IMPROVEMENT OR OPERATION OF A PROJECT.

3 (P) (1) "REVENUES" MEANS THE INCOME, REVENUE, AND OTHER
4 MONEY THE CENTER RECEIVES FROM OR IN CONNECTION WITH A PROJECT,
5 AND ALL OTHER INCOME OF THE CENTER.

6 (2) "REVENUES" INCLUDES GRANTS, RENTALS, RATES, FEES, AND
7 CHARGES FOR THE USE OF THE SERVICES FURNISHED OR AVAILABLE.

8 (Q) (1) "TRUST AGREEMENT" MEANS AN AGREEMENT ENTERED INTO
9 BY THE CENTER TO SECURE A BOND.

10 (2) "TRUST AGREEMENT" MAY INCLUDE A BOND CONTRACT,
11 BOND RESOLUTION, OR OTHER CONTRACT WITH OR FOR THE BENEFIT OF A
12 BONDHOLDER.

14 (A) THE GENERAL ASSEMBLY FINDS THAT:

15 (1) THE UNITED STATES AS A WHOLE, AND THE STATE IN
16 PARTICULAR, ARE FACING INCREASED ENERGY COSTS BASED ON MANY
17 FACTORS, INCLUDING RISING FUEL COSTS, LIMITED INVESTMENT IN
18 GENERATION AND TRANSMISSION FACILITIES, AND A COMPLEX COMBINATION
19 OF MARKET-BASED AND OTHER REGULATORY MECHANISMS THAT BALANCE
20 ENVIRONMENTAL, ECONOMIC, HEALTH, AND WELFARE INTERESTS;

21 (2) CONTINUED EXCLUSIVE RELIANCE ON TRADITIONAL FORMS
22 OF ELECTRICITY SUPPLY ENTRENCHES THE STATE'S DEPENDENCE ON FOSSIL
23 FUELS, WORKING AGAINST THE STATE'S POLICY OF DECREASING GREENHOUSE
24 GAS PRODUCTION, AS EVIDENCED BY THE STATE'S ACCESSION TO THE
25 REGIONAL GREENHOUSE GAS INITIATIVE;

26 (3) "CLEAN ENERGY", A BROAD TERM THAT INCLUDES A WIDE
27 AND VARIED MIXTURE OF STRATEGIES AND TECHNIQUES TO PRODUCE USEFUL
28 ENERGY FROM RENEWABLE AND SUSTAINABLE SOURCES IN A MANNER THAT
29 MINIMIZES FOSSIL FUEL USE AND HARMFUL EMISSIONS, AND TO INCREASE THE
30 EFFICIENT USE OF ENERGY DERIVED FROM ALL SOURCES, OFFERS MANY
31 DIFFERENT OPPORTUNITIES FOR RESIDENTS OF THE STATE TO SUCCEED IN
32 ENTREPRENEURIAL AND OTHER COMMERCIAL ACTIVITY, TO THE OVERALL
33 ECONOMIC AND ENVIRONMENTAL BENEFIT OF THE ENTIRE STATE, AS
34 MEASURED IN IMPROVED AIR AND WATER QUALITY, MODERATED ENERGY
35 EXPENDITURES, AND INCREASED STATE AND LOCAL TAX RECEIPTS;

1 (4) MANY INDIVIDUALS AND BUSINESSES IN THE STATE POSSESS
2 TALENTS AND INTEREST IN THE CLEAN ENERGY TECHNOLOGY SECTOR, WHICH
3 MAY FORM THE BASIS FOR ENCOURAGING DEVELOPMENT AND DEPLOYMENT OF
4 SUSTAINABLE AND RENEWABLE ENERGY TECHNOLOGIES IN THE STATE, THE
5 NATION, AND THE WORLD;

6 (5) THE STATE WILL BENEFIT FROM A TARGETED EFFORT TO
7 ESTABLISH AND INCUBATE CLEAN ENERGY INDUSTRIES IN THE STATE,
8 INCLUDING FINANCIAL ASSISTANCE, INFORMATION SHARING, AND TECHNICAL
9 SUPPORT FOR ENTREPRENEURS IN THE MANUFACTURE AND INSTALLATION OF
10 CLEAN ENERGY TECHNOLOGY; AND

11 (6) IT IS IN THE PUBLIC INTEREST TO ESTABLISH A PUBLIC
12 CORPORATION TO UNDERTAKE THE TASKS OF PROMOTING CLEAN ENERGY
13 INDUSTRIES IN THE STATE, DEVELOPING INCUBATORS FOR THOSE INDUSTRIES,
14 PROVIDING FINANCIAL ASSISTANCE, AND ALSO PROVIDING INFORMATION
15 SHARING AND TECHNICAL ASSISTANCE.

16 (B) THE PURPOSES OF THIS SUBTITLE ARE TO:

17 (1) ENCOURAGE THE DEVELOPMENT OF CLEAN ENERGY
18 INDUSTRIES IN THE STATE;

19 (2) ENCOURAGE THE DEPLOYMENT OF CLEAN ENERGY
20 TECHNOLOGIES IN THE STATE;

21 (3) HELP RETAIN AND ATTRACT BUSINESS ACTIVITY AND
22 COMMERCE IN THE CLEAN ENERGY TECHNOLOGY INDUSTRY SECTOR IN THE
23 STATE;

24 (4) PROMOTE ECONOMIC DEVELOPMENT; AND

25 (5) PROMOTE THE HEALTH, SAFETY, AND WELFARE OF
26 RESIDENTS OF THE STATE.

27 (C) THE GENERAL ASSEMBLY INTENDS THAT:

28 (1) THE CENTER OPERATE AND EXERCISE ITS CORPORATE
29 POWERS IN ALL AREAS OF THE STATE;

30 (2) WITHOUT LIMITING ITS AUTHORITY TO OTHERWISE EXERCISE
31 ITS CORPORATE POWERS, THE CENTER EXERCISE ITS CORPORATE POWERS TO
32 ASSIST GOVERNMENTAL UNITS AND STATE AND LOCAL ECONOMIC

1 DEVELOPMENT AGENCIES TO CONTRIBUTE TO THE EXPANSION,
2 MODERNIZATION, AND RETENTION OF EXISTING ENTERPRISES IN THE STATE AS
3 WELL AS THE ATTRACTION OF NEW BUSINESS TO THE STATE;

4 (3) THE CENTER COOPERATE WITH PRIVATE INDUSTRIES AND
5 LOCAL GOVERNMENTS IN MAXIMIZING NEW ECONOMIC OPPORTUNITIES FOR
6 RESIDENTS OF THE STATE; AND

7 (4) THE CENTER ACCOMPLISH AT LEAST ONE OF THE PURPOSES
8 LISTED IN SUBSECTION (B) OF THIS SECTION AND COMPLEMENT EXISTING
9 STATE MARKETING AND FINANCIAL ASSISTANCE PROGRAMS BY:

10 (I) OWNING PROJECTS;

11 (II) LEASING PROJECTS TO OTHER PERSONS; OR

12 (III) LENDING THE PROCEEDS OF BONDS TO OTHER PERSONS
13 TO FINANCE THE COSTS OF ACQUIRING OR IMPROVING PROJECTS THAT THE
14 PERSONS OWN OR WILL OWN.

22 (A) THERE IS A MARYLAND CLEAN ENERGY CENTER.

23 (B) THE CENTER IS A BODY POLITIC AND CORPORATE AND IS AN
24 INSTRUMENTALITY OF THE STATE.

25 (C) THE EXERCISE BY THE CENTER OF THE POWERS CONFERRED BY
26 THIS SUBTITLE IS THE PERFORMANCE OF AN ESSENTIAL GOVERNMENTAL
27 FUNCTION.

28 (D) THE PURPOSES OF THE CENTER ARE TO:

1 (1) **PROMOTE ECONOMIC DEVELOPMENT AND JOBS IN THE CLEAN**
2 **ENERGY INDUSTRY SECTOR IN THE STATE;**

3 (2) **PROMOTE THE DEPLOYMENT OF CLEAN ENERGY**
4 **TECHNOLOGY IN THE STATE;**

5 (3) **SERVE AS AN INCUBATOR FOR THE DEVELOPMENT OF CLEAN**
6 **ENERGY INDUSTRY IN THE STATE;**

7 (4) **COLLECT, ANALYZE, AND DISSEMINATE INDUSTRY DATA; AND**

8 (5) **PROVIDE OUTREACH AND TECHNICAL SUPPORT TO FURTHER**
9 **THE CLEAN ENERGY INDUSTRY IN THE STATE.**

14 (1) **THE DIRECTOR, OR THE DIRECTOR’S DESIGNEE; AND**

4 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
5 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE**

7 **(F) (1) THE TERM OF AN APPOINTED MEMBER IS 4 YEARS AND**
8 **BEGINS ON JULY 1.**

9 **(2) THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED**
10 **AS REQUIRED BY THE TERMS PROVIDED FOR MEMBERS ON OCTOBER 1, 2008.**

11 **(3) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES**
12 **TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**
