## A BILL ENTITLED

1 AN ACT concerning

2 **Cecil County – Volunteer Length of Service Award Program – Age of**  
3 **Eligibility**

4 FOR the purpose of authorizing certain members of volunteer fire departments, rescue  
5 squads, and ambulance corps to receive certain benefits at a certain age under  
6 the Volunteer Length of Service Award Program in Cecil County.

7 BY repealing and reenacting, with amendments,  
8 Article – Public Safety  
9 Section 7–209  
10 Annotated Code of Maryland  
11 (2003 Volume and 2007 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 7–209.

16 (a) (1) In this section the following words have the meanings indicated.

17 (2) “Board” means the Board of County Commissioners of Cecil  
18 County.

19 (3) “Program” means the Volunteer Length of Service Award Program.

20 (b) In Cecil County, the Board may establish and fund a Volunteer Length of  
21 Service Award Program for qualified members of volunteer fire departments, rescue  
22 squads, and ambulance corps.

- 1 (c) (1) The Board may adopt bylaws for the Program by resolution.
- 2 (2) In the bylaws, the Board may:
- 3 (i) define terms;
- 4 (ii) establish eligibility requirements for certification procedures  
5 based on length of service, number of hours of service, amount of training, number of  
6 hours of training, prior service, or any other criteria considered relevant by the Board  
7 based on requirements and procedures recommended by the Cecil County Fireman's  
8 Association;
- 9 (iii) establish appeals procedures for members who contest  
10 eligibility requirement determinations by the Board;
- 11 (iv) establish a benefits schedule and determine eligibility  
12 requirements, including age and length of service requirements;
- 13 (v) delegate recordkeeping responsibilities of the Program to the  
14 Program administrative committee of the Cecil County Fireman's Association;
- 15 (vi) delegate administration of the Program to the Cecil County  
16 treasurer, a committee or board, an insurer, a financial institution, or any other  
17 agency, group, or organization that the Board determines is competent to administer  
18 the Program;
- 19 (vii) subject to paragraph (3) of this subsection, establish  
20 disability, death, and survivor benefits for qualified individuals;
- 21 (viii) establish any other requirements, criteria, or benefits  
22 considered by the Board to be in the best interest of Cecil County and the best interest  
23 of the volunteer fire departments, rescue squads, and ambulance corps;
- 24 (ix) subject to paragraph (4) of this subsection, allocate from the  
25 general revenue of Cecil County or from any other source, funds for the Program; and
- 26 (x) establish any other provision for the administration of the  
27 Program.
- 28 (3) A surviving spouse benefit is discontinued when the survivor  
29 remarries.
- 30 (4) Funds for the Program allocated from the general revenue of Cecil  
31 County may not exceed:
- 32 (i) \$35,000 during the first year of the Program;
- 33 (ii) \$39,000 during the second year of the Program;

- 1 (iii) \$44,000 during the third year of the Program;  
2 (iv) \$49,000 during the fourth year of the Program;  
3 (v) \$55,000 during the fifth year of the Program; and  
4 (vi) an additional \$10,000 for each additional year of the  
5 Program or whatever amount would make the Program actuarially sound by July 1,  
6 2014.

7 (d) To carry out this section, the Board shall adopt the following provisions  
8 as part of the Program:

9 (1) a member who has certified credit volunteer service on or after  
10 January 1, 1979 or who discontinued active volunteer service before January 1, 1979  
11 may receive credit for this service after being certified in accordance with this section  
12 to have performed 5 years of active volunteer service after January 1, 1979;

13 (2) a member who has completed 25 years of certified volunteer service  
14 and is under the age of 60 years may be qualified and will be eligible for benefits when  
15 the member reaches the age of 60 years if the member is certified to the 25 years of  
16 qualified service before January 1, 1984; [and]

17 (3) after January 1, 1984, **AND ON OR BEFORE JUNE 30, 2008**, a  
18 member who accumulates the proper number of points needed to qualify and certify  
19 for 25 years of service and who fails to remain active or maintain membership in a  
20 volunteer fire company is not disqualified or otherwise restricted from receiving  
21 benefits at the age of 60 years[.]; **AND**

22 (4) **ON OR AFTER JULY 1, 2008, A MEMBER WHO ACCUMULATES**  
23 **THE PROPER NUMBER OF POINTS NEEDED TO QUALIFY AND CERTIFY FOR 25**  
24 **YEARS OF SERVICE MAY RECEIVE BENEFITS AT THE AGE OF 55 YEARS.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
26 July 1, 2008.
