(b) Notwithstanding any other provision of this article, the Board of County
Commissioners may overrule an action of the Frederick County planning commission
under §§ 3.05, 3.06, 3.07, and 3.08 of this article by a majority vote of the membership
of the Board of County Commissioners.

(c) (1) Notwithstanding § 4.07(a) of this article, the members of the board
of appeals may be appointed to terms of 1 to 3 years.
