A BILL ENTITLED

1 AN ACT concerning

$\mathbf{2}$ Task Force to Study the Boating Industry in Maryland 3 FOR the purpose of altering the date by which the Task Force to Study the Boating Industry in Maryland is required to submit its findings and recommendations to 4 5 the Governor and the General Assembly; altering the date for the termination of the Task Force; and generally relating to the Task Force to Study the Boating 6 7 Industry in Maryland. 8 BY repealing and reenacting, with amendments, Chapter 523 of the Acts of the General Assembly of 2007 9 Section 1 and 2 10 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 12Chapter 523 of the Acts of 2007 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That: 1516 (a) There is a Task Force to Study the Boating Industry in Maryland. 17(b) The Task Force consists of the following members: One member of the Senate of Maryland, appointed by the 18 (1)19 President of the Senate; 20One member of the House of Delegates, appointed by the Speaker (2)21 of the House;

18 19	(e) The Department of Business and Economic Development and the Department of Natural Resources shall provide staff for the Task Force.
$20 \\ 21 \\ 22$	(f) A member of the Task Force may not receive compensation for serving as a member of the Task Force but is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.
23	(g) The Task Force shall:

- 1 (iii) Researching the economic impact that marine industries 2 and recreational boaters contribute to the State's economy; and
- 3 (iv) Identifying barriers that limit the State's competitiveness 4 with other states regarding the boating industry and developing methods to overcome 5 these barriers; and
- 6 (2) (i) On or before November 30, 2007, submit a preliminary 7 report of its findings and recommendations to the Governor and, in accordance with § 8 2–1246 of the State Government Article, to the Senate Finance Committee and the 9 House Economic Matters Committee; and
- (ii) On or before [June 30] DECEMBER 31, 2008, submit a final
 report of its findings and recommendations to the Governor and, in accordance with §
 2–1246 of the State Government Article, to the General Assembly.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007. It shall remain effective for a period of [1 year and 1 month] **2 YEARS** and, at the end of [July 31, 2008] **JUNE 30, 2009**, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectJune 1, 2008.
