CHAPTER _____

1 AN ACT concerning

2 **Vehicle Laws – School Buses and Former School Buses – Seat Belts**

3 FOR the purpose of clarifying that a certain type of school vehicle used by certain
4 schools, camps, day nurseries, or day care centers to transport children is not
5 required to be equipped with seat belts and is not subject to certain regulations;
6 establishing that a motor vehicle that formerly was registered as a certain type
7 of school vehicle is not required to be equipped with seat belts and is not subject
8 to certain regulations if it is used by certain schools, camps, day nurseries, or
9 day care centers to transport children; making a stylistic change; and generally
10 relating to seat belts on school buses.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
22 MARYLAND, That the Laws of Maryland read as follows:

1 **Article – Transportation**

2 11–154.

3 (a) “School vehicle” means, except as provided in subsection (b) of this
4 section, any motor vehicle that:

5 (1) Is used regularly for the exclusive transportation of children,
6 students, or teachers for educational purposes or in connection with a school activity;
7 and

8 (2) Is either:

9 (i) A Type I school vehicle, as defined in this subtitle; or

10 (ii) A Type II school vehicle, as defined in this subtitle.

11 (b) “School vehicle” does not include:

12 (1) A privately owned vehicle while it is carrying members of its
13 owner’s household and not operated for compensation; or

14 (2) A vehicle that is registered as a Class M (multipurpose) vehicle
15 under § 13–937 of this article or a Class A (passenger) vehicle under § 13–912 of this
16 article and used to transport children between one or more schools or licensed child
17 care centers or to and from designated areas that are approved by the Administration
18 if:

19 (i) The vehicle is designed for carrying 15 persons or less,
20 including the driver;

21 (ii) The children are permitted to embark or exit the vehicle
22 only at a school or child care center or a designated area approved by the
23 Administration;

24 (iii) The owner has obtained vehicle liability insurance or other
25 security as required by Title 17 of this article; and

26 (iv) The vehicle is equipped with proper seat belts or safety seats
27 so as to permit each child to be secured in a seat belt or a safety seat as required by §§
28 22–412.2 and 22–412.3 of this article.

30 (a) “Type I school vehicle” means a school vehicle that:

31 (1) Is designed and constructed to carry passengers;

1 (2) Is either of the body-on-chassis type construction or integral type
2 construction; and

3 (3) Has a gross vehicle weight of more than 15,000 pounds and
4 provides a minimum of 13 inches of seating space per passenger.

5 (b) "Type I school vehicle" does not include any bus operated by a common
6 carrier under the jurisdiction of a State, regional, or federal regulatory agency or
7 operated by the agency itself.

9 Every motor vehicle that is used by nursery schools, camps, day nurseries, or
10 day care centers for ~~retarded~~ children **WITH DEVELOPMENTAL DISABILITIES** to
11 transport children [and that is not regulated as a "school bus" under this article,] shall
12 be equipped with seat belts for each seat and shall be subject to such other regulations
13 as may be prescribed by the Administration, **UNLESS THE MOTOR VEHICLE:**

14 (1) IS A TYPE I SCHOOL VEHICLE; OR

15 (2) WAS FORMERLY REGISTERED AS A TYPE I SCHOOL VEHICLE.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2008.
