A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County – Board of Education**

3 FOR the purpose of repealing certain provisions of law relating to the composition of
4 certain school board districts in Prince George's County; requiring the elected
5 members of the Prince George's County Board of Education to be elected from
6 certain school board districts; providing for the boundaries of certain school
7 board districts; requiring candidates for the County Board to live in certain
8 school board districts and be registered voters; providing for the terms of the
9 elected members of the County Board; requiring a certain vacancy on the
10 County Board to be filled by a special election if the vacancy occurs within a
11 certain time period; requiring that a certain vacancy on the County Board
12 remain unfilled under certain circumstances; requiring the Prince George's
13 County Council to adopt a certain resolution concerning a special election for
14 the County Board; requiring a special election for the County Board to be
15 conducted at a certain time and in a certain manner under certain provisions of
16 law; requiring that a special election for the County Board be funded by Prince
17 George's County; clarifying that a school board member removed from office is
18 entitled to judicial review of the removal based on a certain record and certain
19 other evidence; repealing certain provisions of law relating to public meetings
20 and executive sessions of the County Board; requiring a certain vote of the
21 County Board to pass a motion of the County Board when there are two or more
22 vacancies on the County Board; repealing a certain provision of law relating to
23 the composition of a committee of the County Board; repealing certain
24 provisions of law relating to the Chief Financial Officer of the county public
25 school system; making stylistic changes; providing for the effective dates of this
26 Act; and generally relating to the Prince George's County Board of Education.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

18 district and precinct boundaries as reviewed and certified by the Prince George’s
19 County Board of Elections or their designees before they were reported to the United
20 States Bureau of the Census as part of the 2000 Census Redistricting Data Program
21 and as those election district and precinct lines are specifically shown on the Public
22 Law 94–171 census block maps provided by the United States Bureau of the Census.

1 (a) In this subtitle, “elected member” means [one of the nine elected
2 members] **A MEMBER** of the Prince George’s County Board [or a member appointed to
3 fill a vacancy of one of these nine members] **ELECTED FROM ONE OF THE NINE**
4 **SCHOOL BOARD DISTRICTS DESCRIBED IN § 3-1001 OF THIS SUBTITLE.**

5 (b) The Prince George’s County Board consists of 10 members as follows:

6 (1) [Five] **NINE** elected members, each of whom resides in a different
7 school board district; **AND**

8 [(2) Four elected members who may reside anywhere in the county;
9 and

10 (3)] **(2)** One student member selected under subsection (f)(2) of this
11 section.

12 (c) (1) [A candidate for the County Board shall be a resident of Prince
13 George’s County for at least 3 years and a registered voter of the county before the
14 election] **ONE MEMBER OF THE COUNTY BOARD SHALL BE ELECTED FROM EACH**
15 **OF THE NINE SCHOOL BOARD DISTRICTS DESCRIBED IN § 3-1001 OF THIS**
16 **SUBTITLE.**

17 (2) From the time of filing as a candidate for election, each candidate
18 [for a position on the County Board representing a school board district shall reside in
19 the school board district the candidate seeks to represent] **SHALL BE A REGISTERED**
20 **VOTER OF THE COUNTY AND A RESIDENT OF THE SCHOOL BOARD DISTRICT THE**
21 **CANDIDATE SEEKS TO REPRESENT.**

22 (3) An elected County Board member shall forfeit the office if the
23 member:

24 (i) [In the case of a member elected to represent a school board
25 district, fails] **FAILS** to reside in the school board district from which the member was
26 elected, unless this change is caused by a change in the boundaries of the district; or

27 (ii) Fails to be a registered voter of the county.

28 (4) A County Board member may not hold another office of profit in
29 county government during the member’s term.

30 (5) Each elected member of the County Board [for a position
31 representing a school board district] shall be nominated by the registered voters of the
32 member’s school board district.

33 (d) [Members of the Prince George’s County Board shall be elected:

1 (1) At the general election every 4 years as required by subsection (g)
2 of this section; and

3 (2) By the registered voters of the entire county.] **THE ELECTED**
4 **MEMBERS OF THE COUNTY BOARD SHALL BE ELECTED:**

5 (1) **AT THE GENERAL ELECTION EVERY 4 YEARS AS REQUIRED BY**
6 **SUBSECTION (G) OF THIS SECTION; AND**

7 (2) **BY THE VOTERS OF THE SCHOOL BOARD DISTRICT THAT EACH**
8 **MEMBER REPRESENTS.**

9 (e) (1) If a candidate for the County Board dies or withdraws the
10 candidacy during the period beginning with the date of the primary and ending 70
11 days before the date of the general election, the Board of [Supervisors of] Elections
12 shall:

13 (i) Replace the name of the deceased or withdrawn candidate
14 on the ballot for the general election with the name of the candidate who received the
15 next highest number of votes in the primary election; or

16 (ii) If a contested primary was not held, reopen the filing
17 process to allow other persons to file as candidates.

18 (2) (i) Except as otherwise provided in subparagraph (ii) of this
19 paragraph, the Board of [Supervisors of] Elections shall add to the ballot for the
20 general election the name of any person who files as a candidate in accordance with
21 paragraph (1)(ii) of this subsection.

22 (ii) The Board of [Supervisors of] Elections may not add
23 additional candidates to the ballot for the general election within 70 days before the
24 date of the election.

25 (f) (1) The student member shall be an eleventh or twelfth grade student
26 in the Prince George's County public school system during the student's term in office.

27 (2) An eligible student shall file a nomination form at least 2 weeks
28 before a special election meeting of the Prince George's Regional Association of
29 Student Governments. Nomination forms shall be made available in the
30 administrative offices of all public senior high schools in the county, the office of
31 student concerns, and the office of the president of the regional association. The
32 delegates to the regional association annually shall elect the student member to the
33 Board at a special election meeting to be held each school year.

34 (3) The student member may vote on all matters before the Board
35 except those relating to:

- 1 (i) Capital and operating budgets;
- 2 (ii) School closings, reopenings, and boundaries;
- 3 (iii) Collective bargaining decisions;
- 4 (iv) Student disciplinary matters;
- 5 (v) Teacher and administrator disciplinary matters as provided
6 under § 6–202(a) of this article; and
- 7 (vi) Other personnel matters.

8 (4) On an affirmative vote of a majority of the elected members of the
9 County Board, the Board may determine if a matter before the Board relates to a
10 subject that the student member may not vote on under paragraph (3) of this
11 subsection.

12 (5) Unless invited to attend by an affirmative vote of a majority **OF**
13 **THE ELECTED MEMBERS** of the County Board, the student member may not attend
14 an executive session that relates to hearings on appeals of special education
15 placements, hearings held under § 6–202(a) of this article, or collective bargaining.

16 (6) The Prince George’s Regional Association of Student Governments
17 may establish procedures for the election of the student member of the County Board.

18 (7) The election procedures established by the Prince George’s
19 Regional Association of Student Governments are subject to the approval of the elected
20 members of the County Board.

21 (g) (1) **[An] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
22 **SUBSECTION, AN** elected member serves for a term of 4 years beginning on the first
23 Monday in December after the member’s election and until the member’s successor is
24 elected and qualifies.

25 **(2) THE TERMS OF THE ELECTED MEMBERS ARE STAGGERED AS**
26 **FOLLOWS:**

27 **(I) THE FIVE ELECTED MEMBERS WHO RECEIVED THE**
28 **LOWEST PERCENTAGE OF VOTES, AS DETERMINED BY THE FINAL VOTE COUNT**
29 **OF THE 2010 GENERAL ELECTION AS CERTIFIED BY THE BOARD OF**
30 **ELECTIONS, SHALL SERVE FOR A TERM OF 2 YEARS; AND**

31 **(II) THE OTHER FOUR MEMBERS ELECTED IN THE 2010**
32 **GENERAL ELECTION SHALL SERVE FOR A TERM OF 4 YEARS.**

1 [(2)] (3) The student member serves for a term of 1 year beginning at
2 the end of a school year.

3 [(3) Subject to the confirmation of the County Council, the County
4 Executive of Prince George's County shall appoint a qualified individual to fill any
5 vacancy on the County Board until a successor is elected and qualifies at the next
6 congressional election.]

7 (4) (I) 1. A SEAT ON THE COUNTY BOARD HELD BY AN
8 ELECTED MEMBER THAT BECOMES VACANT MORE THAN 180 DAYS BEFORE THE
9 END OF THAT MEMBER'S TERM OF OFFICE SHALL BE FILLED FOR THE
10 REMAINDER OF THE TERM AT A SPECIAL ELECTION.

11 2. A SEAT ON THE COUNTY BOARD HELD BY AN
12 ELECTED MEMBER THAT BECOMES VACANT 180 DAYS OR LESS BEFORE THE END
13 OF THAT MEMBER'S TERM OF OFFICE SHALL REMAIN VACANT UNTIL A
14 SUCCESSOR IS ELECTED AND QUALIFIES.

15 (II) 1. A. NO LATER THAN 7 DAYS AFTER THE
16 OCCURRENCE OF A VACANCY ON THE COUNTY BOARD THAT MUST BE FILLED AT
17 A SPECIAL ELECTION, THE COUNTY COUNCIL SHALL ADOPT A RESOLUTION
18 DIRECTING THAT A SPECIAL PRIMARY ELECTION AND SPECIAL GENERAL
19 ELECTION BE HELD IN THE SCHOOL BOARD DISTRICT WHERE THE VACANCY
20 OCCURS.

21 B. THE COUNTY COUNCIL SHALL CONSULT WITH
22 THE BOARD OF ELECTIONS BEFORE ADOPTING THE RESOLUTION.

23 2. SUBJECT TO SUBPARAGRAPH (III) OF THIS
24 PARAGRAPH, THE COUNTY COUNCIL RESOLUTION SHALL SPECIFY:

25 A. THE DATE BY WHICH A CERTIFICATE OF
26 CANDIDACY MUST BE FILED WITH THE BOARD OF ELECTIONS;

27 B. THE DATE OF THE SPECIAL PRIMARY ELECTION;
28 AND

29 C. THE DATE OF THE SPECIAL GENERAL ELECTION.

30 3. NO LATER THAN 7 DAYS AFTER THE ADOPTION OF
31 THE COUNTY COUNCIL RESOLUTION, THE BOARD OF ELECTIONS SHALL
32 PUBLISH THE INFORMATION CONTAINED IN THE RESOLUTION ONCE IN AT
33 LEAST ONE NEWSPAPER OF GENERAL CIRCULATION.

1 (III) 1. A CANDIDATE SHALL FILE A CERTIFICATE OF
2 CANDIDACY WITH THE BOARD OF ELECTIONS NO LATER THAN 28 DAYS BEFORE
3 A SPECIAL PRIMARY ELECTION IN ORDER TO APPEAR ON THE BALLOT.

4 2. THE FOLLOWING PROVISIONS ARE SUBJECT TO
5 SUBSUBPARAGRAPH 3 OF THIS SUBPARAGRAPH:

6 A. A SPECIAL PRIMARY ELECTION SHALL BE HELD
7 ON A TUESDAY AT LEAST 45 DAYS BUT NO LATER THAN 60 DAYS AFTER THE
8 OCCURRENCE OF A VACANCY.

9 B. A SPECIAL GENERAL ELECTION SHALL BE HELD
10 ON A TUESDAY AT LEAST 60 DAYS BUT NO LATER THAN 90 DAYS AFTER THE
11 OCCURRENCE OF A VACANCY.

12 3. A SPECIAL ELECTION MAY NOT BE HELD LESS
13 THAN 30 DAYS BEFORE A REGULARLY SCHEDULED ELECTION.

14 4. ON THE DAY OF A SPECIAL ELECTION, POLLING
15 PLACES SHALL BE OPEN FROM 7 A.M. TO 8 P.M.

16 (IV) 1. NO LATER THAN 10 DAYS BEFORE A SPECIAL
17 PRIMARY ELECTION AND SPECIAL GENERAL ELECTION, THE BOARD OF
18 ELECTIONS SHALL MAIL A SPECIMEN BALLOT TO THE HOUSEHOLD OF EACH
19 REGISTERED VOTER IN THE SCHOOL BOARD DISTRICT WHERE THE VACANCY
20 OCCURS.

21 2. THE SPECIMEN BALLOT SHALL INCLUDE THE
22 NAMES OF THE CANDIDATES IN THE ORDER AND FORM IN WHICH THEY ARE TO
23 APPEAR ON THE BALLOT, TOGETHER WITH A STATEMENT, NOT TO EXCEED 500
24 WORDS, PROVIDED BY EACH CANDIDATE.

25 (V) 1. PRINCE GEORGE'S COUNTY SHALL FUND A
26 SPECIAL ELECTION HELD UNDER THIS PARAGRAPH.

27 2. THE BOARD OF ELECTIONS SHALL SUBMIT A
28 REQUEST FOR A SUPPLEMENTAL BUDGET APPROPRIATION TO THE DIRECTOR
29 OF THE OFFICE OF MANAGEMENT AND BUDGET TO COVER THE COST OF A
30 SPECIAL ELECTION NO LATER THAN 60 DAYS AFTER THE ELECTION.

31 (VI) A SPECIAL ELECTION UNDER THIS PARAGRAPH SHALL
32 BE GOVERNED BY TITLE 8, SUBTITLE 8 OF THE ELECTION LAW ARTICLE AND
33 ALL OTHER RELEVANT PROVISIONS OF LAW RELATING TO THE CONDUCT OF

1 **ELECTIONS EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE OR WHERE**
2 **SUCH CONSTRUCTION WOULD BE UNREASONABLE.**

3 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
4 read as follows:

5 **Article - Education**

6 3-1002.

7 (h) (1) With the approval of the Governor, the State Board may remove a
8 member of the County Board for any of the following reasons:

9 (i) Immorality;

10 (ii) Misconduct in office;

11 (iii) Incompetency; or

12 (iv) Willful neglect of duty.

13 (2) Before removing a member, the State Board shall send the member
14 a copy of the charges pending and give the member an opportunity within 10 days to
15 request a hearing.

16 (3) If the member requests a hearing within the 10-day period:

17 (i) The State Board promptly shall hold a hearing, but a
18 hearing may not be set within 10 days after the State Board sends the member a
19 notice of the hearing; and

20 (ii) The member shall have an opportunity to be heard publicly
21 before the State Board in the member's own defense, in person or by counsel.

22 (4) A member removed under this subsection has the right to [a de
23 novo] **JUDICIAL** review of the removal by the Circuit Court for Prince George's County
24 **BASED ON AN ADMINISTRATIVE RECORD AND SUCH ADDITIONAL EVIDENCE AS**
25 **WOULD BE AUTHORIZED BY § 10-222(F) AND (G) OF THE STATE GOVERNMENT**
26 **ARTICLE.**

27 (i) While serving on the County Board, a member may not be a candidate for
28 a public office other than a position on the County Board.

29 3-1003.

30 (a) From and after December 4, 2006, at the beginning of each member's full
31 term, the [chairman] **CHAIR** of the County Board is entitled to receive \$19,000

1 annually as compensation and the other elected members are each entitled to receive
2 \$18,000 annually as compensation.

3 (b) (1) After submitting vouchers under the rules and regulations adopted
4 by the County Board, the [chairman] **CHAIR** and the other members, including the
5 student member, are entitled to the allowances for travel and other expenses provided
6 in the Prince George's County budget.

7 (2) A member of the County Board may not be reimbursed more than
8 \$7,000 in travel and other expenses incurred in a single fiscal year.

29 (I) **FIVE MEMBERS WHEN THE STUDENT MEMBER IS**
30 **VOTING; OR**

31 (II) **FOUR MEMBERS WHEN THE STUDENT MEMBER IS NOT**

1 [(a)] In addition to the powers otherwise granted to the County Board in this
2 article, the County Board or a designated committee of the County Board may hear an
3 appeal from a decision of the County Superintendent that relates to the grade,
4 transfer, tuition, or any aspect of participation in a program or activity of a specific
5 student who is not subject to the provisions of Title 8, Subtitle 4 of this article.

6 [(b)] A designated committee shall consist of at least 5 members of the Board
7 and at least 5 members of a designated committee shall be present to constitute a

10 (a) There is a Chief Financial Officer in the Prince George's County public
11 school system who shall:

12 (1) Be responsible for the day-to-day management and oversight of
13 the fiscal affairs of the Prince George's County public school system; and

14 (2) Report directly to the County Superintendent.

15 (b) The County Superintendent shall, subject to the approval of the County
16 Board:

17 (1) Select the Chief Financial Officer; and

18 (2) Establish the salary of the Chief Financial Officer.

20 continued employment is contingent on the effective fiscal management of the Prince
21 George's County public schools.
