A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure Article Additions**

3 FOR the purpose of adding three new titles to the Criminal Procedure Article of the
4 Annotated Code of Maryland, to be designated and known as “Title 14. Office of
5 the State Prosecutor”, “Title 15. Office of the State’s Attorney”, and “Title 16.
6 Office of the Public Defender”; revising, restating, and recodifying certain laws
7 applicable to the Office of the State Prosecutor, including laws concerning the
8 establishment of the Office, the eligibility of individuals to be nominated and
9 appointed to be the State Prosecutor, the establishment and membership of the
10 State Prosecutor Selection and Disabilities Commission, the filling of vacancies
11 in the Office, the reprimand or removal of the State Prosecutor, the general
12 powers and duties of the State Prosecutor, investigations, reports, and
13 prosecutions of the Office, the budget and staff of the Office, and meetings with
14 the Attorney General and State’s Attorneys; revising, restating, and recodifying
15 certain laws applicable to the Office of the State’s Attorney, including laws
16 concerning the duties of the State’s Attorney, the subpoena power in a criminal
17 investigation, and the appointment of an interim State’s Attorney, the
18 establishment of the State’s Attorneys’ Coordination Council, the establishment
19 of the Office of the State’s Attorneys’ Coordinator, the duties of the Coordinator,
20 and the salary, expenses, staffing, and other matters regarding the State’s
21 Attorneys for Allegany County, Anne Arundel County, Baltimore County,
22 Calvert County, Caroline County, Carroll County, Cecil County, Charles
23 County, Dorchester County, Frederick County, Garrett County, Harford County,
24 Howard County, Kent County, Montgomery County, Prince George’s County,
25 Queen Anne’s County, St. Mary’s County, Somerset County, Talbot County,
26 Washington County, Wicomico County, and Worcester County; revising,
27 restating, and recodifying certain laws applicable to the Office of the Public
28 Defender, including laws concerning the establishment of the Office of the
29 Public Defender, Office personnel, representation of indigent individuals,

1 termination of representation, representation in federal court, duties and
2 powers of the Public Defender, panel attorneys, privileged communications,
3 eligibility for services, reimbursement for services, liens, the Board of Trustees
4 of the Office of the Public Defender, regional advisory boards, reports of the
5 Public Defender, and appropriations; defining certain terms; providing for the
6 construction and application of this Act; providing for the continuity of certain
7 units and the terms of certain officials; providing for the continuity of the status
8 of certain transactions, employees, rights, duties, titles, interests, licenses,
9 registrations, certifications, and permits; and generally relating to laws of the
10 State relating to the Office of the State Prosecutor, the Office of the State's
11 Attorney, and the Office of the Public Defender.

5 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
6 read as follows:

7 **Article – Criminal Procedure**

8 **TITLE 14. OFFICE OF THE STATE PROSECUTOR.**

9 **14–101. “COMMISSION” DEFINED.**

10 **IN THIS TITLE, “COMMISSION” MEANS THE STATE PROSECUTOR**
11 **SELECTION AND DISABILITIES COMMISSION.**

12 REVISOR’S NOTE: This section is new language added to provide a convenient
13 reference to the “State Prosecutor Selection and Disabilities
14 Commission”.

15 **14–102. OFFICE OF THE STATE PROSECUTOR.**

16 **(A) ESTABLISHED.**

17 **(1) THERE IS AN OFFICE OF THE STATE PROSECUTOR.**

18 **(2) THE OFFICE OF THE STATE PROSECUTOR IS AN**
19 **INDEPENDENT UNIT IN THE OFFICE OF THE ATTORNEY GENERAL.**

20 **(B) ELIGIBILITY.**

21 **(1) AN INDIVIDUAL IS ELIGIBLE TO BE THE STATE PROSECUTOR**
22 **ONLY IF THE INDIVIDUAL:**

23 **(I) EXECUTES AN AFFIDAVIT THAT THE INDIVIDUAL WILL**
24 **NOT ACCEPT APPOINTMENT TO, OR BE A CANDIDATE FOR, A STATE OR LOCAL**
25 **OFFICE DURING THE PERIOD OF SERVICE AS THE STATE PROSECUTOR AND FOR**
26 **AT LEAST 3 YEARS IMMEDIATELY AFTER THE INDIVIDUAL LAST SERVES AS THE**
27 **STATE PROSECUTOR; AND**

28 **(II) HAS LAWFULLY AND ACTIVELY PRACTICED LAW IN THE**
29 **STATE FOR AT LEAST 5 YEARS.**

1 **(2) THE STATE PROSECUTOR SHALL RENEW THE AFFIDAVIT**
2 **EVERY 2 YEARS DURING THE PERIOD OF SERVICE.**

3 **(3) A FAILURE TO RENEW THE AFFIDAVIT UNDER THIS**
4 **SUBSECTION SHALL SUBJECT THE STATE PROSECUTOR TO REMOVAL FROM**
5 **OFFICE UNDER THIS SECTION.**

6 **(C) NOMINATION; APPOINTMENT; TENURE.**

7 **(1) THE STATE PROSECUTOR SHALL BE:**

8 **(I) NOMINATED BY THE COMMISSION; AND**

9 **(II) APPOINTED BY THE GOVERNOR WITH THE ADVICE AND**
10 **CONSENT OF THE SENATE.**

11 **(2) THE TERM OF THE STATE PROSECUTOR IS 6 YEARS.**

12 **(3) AT THE END OF A TERM, THE STATE PROSECUTOR**
13 **CONTINUES TO SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

14 **(D) REMOVAL.**

15 **ONLY ON THE RECOMMENDATION OF THE COMMISSION, THE GOVERNOR**
16 **MAY REMOVE THE STATE PROSECUTOR FOR:**

17 **(1) MISCONDUCT IN OFFICE;**

18 **(2) PERSISTENT FAILURE TO PERFORM THE DUTIES OF THE**
19 **OFFICE; OR**

20 **(3) CONDUCT PREJUDICIAL TO THE PROPER ADMINISTRATION OF**
21 **JUSTICE.**

22 **(E) SALARY.**

23 **THE STATE PROSECUTOR IS ENTITLED TO THE SALARY PROVIDED IN THE**
24 **STATE BUDGET, BUT NOT LESS THAN THE SALARY OF A JUDGE OF A CIRCUIT**
25 **COURT.**

26 **REVISOR'S NOTE: This section is new language derived without substantive**
27 **change from former SG § 9-1201.**

1 In subsection (b)(1)(i) of this section, the former phrase “under oath” is
2 deleted in light of the reference to “affidavit”.

3 Also in subsection (b)(1)(i) of this section, the former reference to a State
4 or local office “, whether appointive or elective,” is deleted as redundant,
5 because this subsection states that an individual will not accept
6 “appointment to, or be a candidate for,” a State or local office.

7 In subsection (b)(1)(ii) of this section, the former phrase “at the time of
8 appointment” is deleted as surplusage.

9 The Criminal Procedure Article Additions Review Committee notes, for
10 consideration by the General Assembly, that the Office of the State
11 Prosecutor is an independent unit but is no longer physically housed in
12 the Office of the Attorney General, and the Office of the State Prosecutor
13 is not budgeted as part of the Office of the Attorney General. Thus, the
14 reference in subsection (a)(2) of this section to the Office as being “in the
15 Office of the Attorney General” may be obsolete.

16 The Committee also notes that subsection (b)(1) of this section states that
17 the State Prosecutor must file an affidavit stating that the State
18 Prosecutor will not accept appointment to, or be a candidate for, a State
19 or local office during service as the State Prosecutor and for at least 3
20 years thereafter. Subsection (b)(2) states that the State Prosecutor must
21 renew the affidavit every 2 years during the period of service. These
22 provisions, however, do not state with whom the State Prosecutor should
23 file an original or renewed affidavit.

24 The Committee also notes that subsection (b)(3) of this section states that
25 a failure to renew the affidavit shall subject the State Prosecutor to
26 removal from office under this section. The only provision in this section
27 that covers removal is subsection (d). The relationship, however, between
28 subsection (b) and subsection (d) is unclear. Subsection (d) requires that
29 removal be first recommended by the Commission and states three
30 grounds for removal, none of which specifically includes failure to renew
31 the affidavit.

33 **14–103. STATE PROSECUTOR SELECTION AND DISABILITIES COMMISSION.**

34 (A) **ESTABLISHED.**

35 **THERE IS A STATE PROSECUTOR SELECTION AND DISABILITIES**
36 **COMMISSION.**

37 (B) **MEMBERSHIP.**

1 **THE COMMISSION CONSISTS OF:**

2 **(1) THE ATTORNEY GENERAL; AND**

3 **(2) SIX INDIVIDUALS APPOINTED BY THE GOVERNOR AS**
4 **FOLLOWS:**

5 **(I) TWO INDIVIDUALS SHALL BE APPOINTED FROM A LIST**
6 **OF TWO OR MORE NOMINEES SUBMITTED BY THE PRESIDENT OF THE SENATE:**

7 **1. ONLY ONE OF THE INDIVIDUALS APPOINTED**
8 **SHALL BE A LAWYER; AND**

9 **2. NONE OF THE NOMINEES MAY BE A MEMBER OF**
10 **THE GENERAL ASSEMBLY OR A FULL-TIME STATE EMPLOYEE;**

11 **(II) TWO INDIVIDUALS SHALL BE APPOINTED FROM A LIST**
12 **OF TWO OR MORE NOMINEES SUBMITTED BY THE SPEAKER OF THE HOUSE OF**
13 **DELEGATES:**

14 **1. ONLY ONE OF THE INDIVIDUALS APPOINTED**
15 **SHALL BE A LAWYER; AND**

16 **2. NONE OF THE NOMINEES MAY BE A MEMBER OF**
17 **THE GENERAL ASSEMBLY OR A FULL-TIME STATE EMPLOYEE;**

18 **(III) ONE INDIVIDUAL WHO:**

19 **1. SHALL BE APPOINTED FROM A LIST OF ONE OR**
20 **MORE NOMINEES SUBMITTED BY THE BOARD OF GOVERNORS OF THE**
21 **MARYLAND STATE BAR ASSOCIATION; AND**

22 **2. IS A LAWYER ADMITTED TO PRACTICE LAW IN THE**
23 **STATE; AND**

24 **(IV) ONE INDIVIDUAL WHO:**

25 **1. SHALL BE APPOINTED FROM A LIST OF ONE OR**
26 **MORE NOMINEES SUBMITTED BY THE GOVERNING BOARD OF THE MARYLAND**
27 **STATE'S ATTORNEYS ASSOCIATION; AND**

1 **2. IS A STATE'S ATTORNEY AT THE TIME OF**
2 **APPOINTMENT AND THROUGHOUT THE INDIVIDUAL'S TERM ON THE**
3 **COMMISSION.**

4 **(C) APPOINTMENT.**

5 **(1) THE GOVERNOR SHALL APPOINT THE MEMBERS OF THE**
6 **COMMISSION FROM THE NOMINEES SUBMITTED TO THE GOVERNOR UNDER**
7 **THIS SECTION.**

8 **(2) THE GOVERNOR MAY REJECT AN INDIVIDUAL AS A NOMINEE**
9 **ONLY FOR CAUSE.**

10 **(3) IF THE GOVERNOR REJECTS AN INDIVIDUAL AS A NOMINEE,**
11 **THE GOVERNOR SHALL REQUEST THE APPROPRIATE NOMINATING AUTHORITY**
12 **TO SUBMIT ANOTHER NOMINEE.**

13 **(D) TENURE.**

14 **(1) THE TERM OF AN APPOINTED MEMBER IS 4 YEARS.**

15 **(2) THE TERMS OF APPOINTED MEMBERS ARE STAGGERED AS**
16 **REQUIRED BY THE TERMS IN EFFECT FOR MEMBERS ON OCTOBER 1, 2008.**

17 **(3) AN APPOINTED MEMBER SERVES UNTIL A SUCCESSOR IS**
18 **APPOINTED AND QUALIFIES.**

19 **(4) AN APPOINTED MEMBER IS ELIGIBLE FOR REAPPOINTMENT.**

20 **(E) CHAIR.**

21 **FROM AMONG THE MEMBERS, THE GOVERNOR SHALL DESIGNATE THE**
22 **CHAIR OF THE COMMISSION FOR THE PERIOD THAT THE GOVERNOR**
23 **DETERMINES.**

24 **(F) VACANCIES.**

25 **A VACANCY THAT OCCURS ON THE COMMISSION SHALL BE FILLED BY THE**
26 **GOVERNOR IN THE SAME MANNER AS PROVIDED FOR APPOINTMENTS IN THIS**
27 **SECTION.**

28 **(G) COMPENSATION AND REIMBURSEMENT FOR EXPENSES.**

29 **A MEMBER OF THE COMMISSION:**

1 **(1) MAY NOT RECEIVE COMPENSATION FOR SERVING ON THE**
 2 **COMMISSION; BUT**

3 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
 4 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE**
 5 **BUDGET.**

6 REVISOR'S NOTE: This section is new language derived without substantive
 7 change from former SG § 9–1211.

8 In subsection (b)(1) of this section, the former reference to the Attorney
 9 General “, ex officio, but with power to vote” is deleted as unnecessary
 10 and possibly misleading because serving “ex officio” does not place a limit
 11 on voting rights, despite a common misperception that it indicates a
 12 nonvoting status.

13 In subsection (b)(2)(iv) of this section, the former reference to the
 14 Maryland State’s Attorneys Association “, Incorporated, or its successor”
 15 is deleted as surplusage.

16 In subsection (d) of this section, the references to “appointed” members
 17 are added to clarify that subsection (d) does not apply to the Attorney
 18 General, who serves ex officio.

19 In subsection (d)(2) of this section, the reference to terms being
 20 “staggered as required by the terms in effect for members on October 1,
 21 2008” is substituted for the former obsolete reference to the initial terms
 22 of the initial appointees. This substitution is not intended to alter the
 23 term of any member of the Commission. *See* § __ of Ch. __, Acts of 2008.
 24 The terms of the members serving on October 1, 2008, end as follows: (1)
 25 two members on December 31, 2009; (2) two members on December 31,
 26 2011; and (3) two members on December 31, 2013.

27 In subsection (e) of this section, the reference to “chair” is substituted for
 28 the former reference to “chairman” because SG § 2–1238 requires the use
 29 of words that are neutral as to gender to the extent practicable.

30 In subsection (g)(2) of this section, the reference to “Standard State
 31 Travel Regulations” is standard language added to reflect that, under SF
 32 § 10–203, the Board of Public Works has adopted regulations for
 33 reimbursement of expenses. *See* COMAR 23.02.01.01 through .12.

34 Defined term: “Commission” § 14–101

35 **14–104. FILLING VACANCIES IN OFFICE OF STATE PROSECUTOR.**

1 **(A) RECOMMENDATIONS.**

2 **ON NOTIFICATION BY THE GOVERNOR THAT A VACANCY EXISTS OR IS**
3 **ABOUT TO OCCUR IN THE POSITION OF STATE PROSECUTOR, THE COMMISSION**
4 **SHALL:**

5 **(1) SEEK AND REVIEW APPLICATIONS OF PROPOSED NOMINEES;**

6 **(2) NOTIFY AND REQUEST RECOMMENDATIONS FROM THE**
7 **MARYLAND STATE BAR ASSOCIATION; AND**

8 **(3) SEEK RECOMMENDATIONS FROM MEMBERS OF THE**
9 **COMMISSION AND INTERESTED CITIZENS AND GROUPS.**

10 **(B) NOMINATIONS.**

11 **THE COMMISSION SHALL:**

12 **(1) INTERVIEW AND EVALUATE EACH ELIGIBLE APPLICANT; AND**

13 **(2) NOMINATE TO THE GOVERNOR, ON A VOTE TAKEN BY SECRET**
14 **BALLOT, ONE OR MORE INDIVIDUALS WHOM A MAJORITY OF THE AUTHORIZED**
15 **MEMBERSHIP OF THE COMMISSION FINDS TO BE LEGALLY AND**
16 **PROFESSIONALLY QUALIFIED.**

17 **(C) REPORT TO GOVERNOR.**

18 **THE COMMISSION SHALL REPORT, IN WRITING, TO THE GOVERNOR THE**
19 **NAME OF THE INDIVIDUAL OR INDIVIDUALS IT NOMINATES WITHIN 70 DAYS**
20 **AFTER NOTIFICATION THAT A VACANCY EXISTS OR IS ABOUT TO OCCUR.**

21 **(D) REJECTION OF NOMINEE.**

22 **(1) (I) THE GOVERNOR MAY REJECT A NOMINEE FOR CAUSE.**

23 **(II) IF A NOMINEE IS REJECTED FOR CAUSE, THE**
24 **COMMISSION SHALL SUBMIT ANOTHER NOMINEE.**

25 **(2) IF THE GOVERNOR REJECTS A NOMINEE:**

26 **(I) THE GOVERNOR SHALL SEND TO THE COMMISSION A**
27 **WRITTEN STATEMENT THAT CONTAINS THE REASONS FOR THE REJECTION; AND**

1 **(II) A COPY OF THE STATEMENT OF REJECTION SHALL BE**
2 **FURNISHED TO THE NOMINEE.**

3 **(3) THE STATEMENT SHALL BE CONFIDENTIAL AND PRIVILEGED,**
4 **UNLESS THE PRIVILEGE IS DEEMED WAIVED BY THE COMMISSION BY THE ACTS**
5 **OF THE NOMINEE IN PRESENTING TO THE PUBLIC THE REASON FOR THE**
6 **REJECTION.**

7 **(4) THE COMMISSION MAY MAKE THE STATEMENT PUBLIC.**

8 **(E) TIME OF APPOINTMENT OR REJECTION.**

9 **THE GOVERNOR SHALL EXERCISE THE POWER OF APPOINTMENT OR**
10 **REJECTION WITHIN 30 DAYS AFTER RECEIPT OF THE COMMISSION'S REPORT.**

11 REVISOR'S NOTE: This section is new language derived without substantive
12 change from former SG § 9-1212.

13 In the introductory language of subsection (a) of this section, the
14 reference to the "position of" State Prosecutor is substituted for the
15 former reference to the "Office of the" State Prosecutor for clarity.

16 In subsection (b)(2) of this section, the former reference to the "entire"
17 authorized membership is deleted as surplusage.

18 In subsection (d)(3) of this section, the former reference to "secret" is
19 deleted as implicit in the references to "confidential" and "privileged".

20 Also in subsection (d)(3) of this section, the former reference to the
21 "nominating" Commission is deleted as surplusage.

22 The Criminal Procedure Article Additions Review Committee notes, for
23 consideration by the General Assembly, that subsection (d)(3) of this
24 section appears to be inconsistent with subsection (d)(4). Subsection (d)(3)
25 states that a rejection statement "shall be confidential and privileged,
26 unless the privilege is deemed waived by the Commission by the acts of
27 the nominee in presenting to the public the reason for rejection".
28 Subsection (d)(4), however, states without qualification that the
29 Commission "may make the statement public".

31 **14-105. REPRIMAND OR REMOVAL.**

32 **(A) AUTHORITY OF COMMISSION.**

1 **THE COMMISSION MAY REPRIMAND OR RECOMMEND TO THE GOVERNOR**
2 **THE REMOVAL OF THE STATE PROSECUTOR IF, AFTER A HEARING, THE**
3 **COMMISSION FINDS THAT THE STATE PROSECUTOR IS GUILTY OF:**

4 **(1) MISCONDUCT IN OFFICE;**

5 **(2) PERSISTENT FAILURE TO PERFORM THE DUTIES OF THE**
6 **OFFICE; OR**

7 **(3) CONDUCT PREJUDICIAL TO THE PROPER ADMINISTRATION OF**
8 **JUSTICE.**

9 **(B) CONFIDENTIAL AND PRIVILEGED PROCEEDINGS AND EVIDENCE.**

10 **(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
11 **SUBSECTION, THE PROCEEDINGS, TESTIMONY, AND OTHER EVIDENCE BEFORE**
12 **THE COMMISSION ARE CONFIDENTIAL AND PRIVILEGED.**

13 **(2) ON TAKING FINAL ACTION, THE COMMISSION MAY MAKE ITS**
14 **ORDER AND THE PROCEEDINGS, TESTIMONY, AND OTHER EVIDENCE PUBLIC.**

15 **(C) INVESTIGATIONS; HEARINGS.**

16 **(1) ON COMPLAINT OR ON ITS OWN INITIATIVE, THE COMMISSION**
17 **MAY INVESTIGATE ALLEGATIONS AGAINST THE STATE PROSECUTOR THAT MAY**
18 **WARRANT REMOVAL OR REPRIMAND.**

19 **(2) THE COMMISSION MAY:**

20 **(I) CONDUCT HEARINGS;**

21 **(II) ADMINISTER OATHS AND AFFIRMATIONS;**

22 **(III) ISSUE PROCESS TO COMPEL THE ATTENDANCE OF**
23 **WITNESSES AND THE PRODUCTION OF EVIDENCE; AND**

24 **(IV) REQUIRE A PERSON TO TESTIFY AND PRODUCE**
25 **EVIDENCE BY GRANTING THE PERSON IMMUNITY FROM PROSECUTION,**
26 **PENALTY, OR FORFEITURE.**

27 **REVISOR'S NOTE: This section is new language derived without substantive**
28 **change from former SG § 9-1213.**

1 In subsection (c)(1) of this section, the reference to the Commission's own
2 "initiative" is substituted for the former reference to the Commission's
3 own "motion" to conform to the terminology used in § 14-107(a)(3) of this
4 title.

5 Also in subsection (c)(1) of this section, the reference to a "reprimand" is
6 substituted for the former reference to "discipline" to conform to the
7 terminology used in this section.

8 Also in subsection (c)(1) of this section, the former phrase "if true" is
9 deleted as surplusage.

12 **14-106. GENERAL POWERS AND DUTIES OF STATE PROSECUTOR.**

13 **THE STATE PROSECUTOR HAS THE POWERS AND DUTIES ESTABLISHED**
14 **UNDER §§ 14-107 THROUGH 14-111 OF THIS TITLE.**

15 REVISOR'S NOTE: This section is new language derived without substantive
16 change from former SG § 9-1202.

17 The former reference to "responsibilities" is deleted as unnecessary in
18 light of the reference to the "duties" of the State Prosecutor.

19 **14-107. INVESTIGATIONS.**

20 (A) **IN GENERAL.**

12 **TREASURER SHOULD MAKE THE ACCOUNTANT FOR INSOLVENCY OR**
13 **NONRESIDENCE.**

3 (4) THE STATE'S ATTORNEY SHALL SUBMIT THE ACCOUNTING TO
4 THE JUDGES OF THE CIRCUIT COURT OF THE COUNTY SERVED BY THE STATE'S
5 ATTORNEY WITH AN AFFIDAVIT AS TO THE CORRECTNESS OF THE ACCOUNTING
6 AND THE FAIRNESS OF ANY CHARGES.

7 (5) THE JUDGES OF THE CIRCUIT COURT SHALL EXAMINE THE
8 ACCOUNTING SUBMITTED BY THE STATE'S ATTORNEY.

9 (6) IF THE ACCOUNTING IS FAIR, REASONABLE, AND PROPERLY
10 CHARGEABLE TO THE COUNTY, THE JUDGES OF THE CIRCUIT COURT SHALL
11 CERTIFY THE ACCOUNTING.

12 (7) IF THE ACCOUNTING IS CERTIFIED BY A MAJORITY OF THE

 13 references in this section to the “judges of the circuit court”, the “clerk of
 14 the board of county commissioners”, and “county commissioners” may be
 15 dated and are inapplicable to many modern county governments and the
 16 courts. For example, Dorchester, Harford, Howard, Talbot, and Wicomico
 17 counties and Baltimore City are not exempted from this section and are
 18 not governed by a board of county commissioners.

 20 nonjudicial duty on the judges of the circuit court. *See Robey v.*

5 **SUBSECTION (C)(2)(II) OF THIS SECTION SHALL SERVE FULL TIME AND MAY NOT**
6 **ENGAGE IN THE PRIVATE PRACTICE OF LAW.**

7 **(II) THE ASSISTANT STATE’S ATTORNEY APPOINTED UNDER**
8 **SUBSECTION (C)(2)(III) OF THIS SECTION MAY ENGAGE IN THE PRIVATE**
9 **PRACTICE OF LAW.**

10 **(3) A SPECIAL INVESTIGATOR APPOINTED UNDER SUBSECTION**
11 **(D) OF THIS SECTION SHALL SERVE FULL TIME AND MAY NOT ENGAGE IN OTHER**
12 **EMPLOYMENT.**

21 deleted as included in the reference to “compensation”.

22 In subsection (e)(1) of this section, the former reference to the
23 requirement that the State’s Attorney serves full time “[a]fter December
24 31, 1998” is deleted as obsolete.

25 In subsection (e)(2)(i) of this section, the former phrase “at any time in
26 any jurisdiction during his tenure of office” is deleted as unnecessary.

27 In subsection (e)(3) of this section, the requirement that a special
28 investigator “serve full time” is substituted for the former requirement
29 that a special investigator “devote his full time and attention to his duty
30 ... during the time he is employed as a special investigator” for brevity.

31 The Criminal Procedure Article Additions Review Committee notes, for
32 consideration by the General Assembly, that subsection (c) of this section
33 may be outdated. Currently, the Office of State’s Attorney has two deputy
34 State’s Attorneys and five assistant State’s Attorneys. The salary

1 amounts stated in subsection (c) of this section are no longer valid. In
2 addition, there is no longer a resident circuit court judge in the county.
3 Instead, there are three judges, one of whom is the administrative judge.

5 GENERAL REVISOR'S NOTE TO SUBTITLE:

6 Former Art. 10, § 40 did not contain a specific subsection relating to the Office
7 of State's Attorney for Baltimore City. Consequently, that omission is reflected in this
8 revision. Unlike the 23 other counties, the law regarding the salaries of the State's
9 Attorney, the deputy State's Attorney, and assistant State's Attorneys and the
10 appointment of deputy and assistant State's Attorneys in Baltimore City is found in
11 the Maryland Constitution and in the Baltimore City Charter, and it has been
12 acknowledged by the Maryland Court of Special Appeals.

13 Article V, § 9 of the Maryland Constitution states:

14 "... the State's Attorney for Baltimore City shall have the power to appoint a
15 Deputy and such other Assistants as the Supreme Bench of Baltimore City may
16 authorize or approve and until otherwise provided by the General Assembly, the said
17 State's Attorney, Deputy and Assistants shall receive the following annual salaries:
18 State's Attorney, seven thousand five hundred dollars; Deputy State's Attorney, five
19 thousand dollars; Assistant State's Attorneys, four thousand dollars each; said
20 salaries, or such salaries as the General Assembly may subsequently provide and such
21 expenses for conducting the Office of the State's Attorney as the Supreme Bench of
22 Baltimore City may authorize or approve shall be paid by the Mayor and City Council
23 of Baltimore to the extent that the total of them exceeds the fees of his office, or as the
24 General Assembly shall otherwise provide, and the Mayor and City Council of
25 Baltimore shall not be liable for appearance fees to the State's Attorney."

26 Subsequent constitutional amendments in 1912, 1924, 1943, and 1976 provided
27 specific salary amounts or authorized "such salaries as the General Assembly may
28 subsequently provide."

29 Further, law concerning the salaries of the employees of the Office of State's
30 Attorney in Baltimore City is in the Baltimore City Charter. Article VI, § 16 of the
31 current Baltimore City Charter states:

32 "The Board of Estimates is hereby authorized and empowered to fix the salaries
33 of the State's Attorney, the Deputy State's Attorney, and Assistant State's Attorneys of
34 Baltimore City, in amounts not less than those prescribed by the Constitution of
35 Maryland."

36 According to the Budget Director for Baltimore City, staffing and office expenses
37 of the Office of the State's Attorney are reflected in the Office's budget request
38 included in the Board's Ordinance of Estimates that the Board submits to the City
39 Council for approval.

1 Finally, legal authority of the State's Attorney to appoint deputy and assistant
 2 State's Attorneys in Baltimore City has been addressed by the Court of Special
 3 Appeals. In *State v. Aquilla*, 18 Md. App. 487, 1973 (cert. denied, September 18, 1973)
 4 the court recognized that the Deputy State's Attorneys and Assistant State's Attorneys
 5 for Baltimore City are appointed pursuant to Article V, § 9 of the State Constitution.
 6 The court upheld the legitimacy of the State's Attorney for Baltimore City to appoint
 7 Special Assistant State's Attorneys under the authorization and with the approval of
 8 the Supreme Bench of Baltimore City to present cases to the grand jury concerning
 9 irregularities in the Traffic Division of the Municipal Court for the City.

25 **"DISTRICT" MEANS AN AREA CONFORMING TO THE GEOGRAPHIC**
 26 **BOUNDARIES OF A DISTRICT COURT DISTRICT ESTABLISHED IN § 1-602 OF THE**
 27 **COURTS ARTICLE.**

28 REVISOR'S NOTE: This subsection is new language derived without
 29 substantive change from former Art. 27A, § 2(c).

30 The former reference to an area "comprising one or more political
 31 subdivisions" is deleted as unnecessary in light of the reference to an area

1 “conforming to the geographic boundaries of a District Court district
2 established in § 1–602 of the Courts Article”.

3 **(D) INDIGENT INDIVIDUAL.**

4 **“INDIGENT INDIVIDUAL” MEANS AN INDIVIDUAL WHO QUALIFIES AS AN**

15 described” is deleted as surplusage.

16 Defined term: “District” § 16–101

17 **(F) PANEL ATTORNEY.**

18 **“PANEL ATTORNEY” MEANS AN ATTORNEY WHO IS ELIGIBLE FOR**
19 **APPOINTMENT AS AN ATTORNEY FOR AN INDIGENT INDIVIDUAL.**

20 REVISOR’S NOTE: This subsection is new language derived without
21 substantive change from former Art. 27A, § 2(e), as it related to an
22 attorney who qualifies and is eligible for appointment as counsel for an
23 indigent individual.

24 The former reference to an attorney who “qualifies” for appointment as
25 counsel to an indigent individual is deleted as implied in the reference to
26 an attorney who “is eligible” for appointment.

27 The former reference to an indigent individual “as defined by this article”
28 is deleted as surplusage.

29 The reference to an “attorney” is substituted for the former reference to a
30 “counsel” to conform to the terminology used throughout this title.

1 Defined term: “Indigent individual” § 16–101

2 (G) **REGIONAL ADVISORY BOARD.**

3 **“REGIONAL ADVISORY BOARD” MEANS A PUBLIC DEFENDER REGIONAL**
4 **ADVISORY BOARD.**

5 REVISOR’S NOTE: This subsection is new language derived without
6 substantive change from former Art. 27A, § 10(a).

7 (H) **SERIOUS OFFENSE.**

8 **“SERIOUS OFFENSE” MEANS:**

9 (1) **A FELONY;**

10 (2) **A MISDEMEANOR OR OFFENSE PUNISHABLE BY CONFINEMENT**
11 **FOR MORE THAN 3 MONTHS OR A FINE OF MORE THAN \$500;**

12 (3) **A DELINQUENT ACT THAT WOULD BE A SERIOUS OFFENSE IF**
13 **COMMITTED BY AN ADULT; OR**

14 (4) **AN OFFENSE IN WHICH, IN THE OPINION OF THE COURT, THE**
15 **COMPLEXITY OF THE MATTER OR THE YOUTH, INEXPERIENCE, OR MENTAL**
16 **CAPACITY OF THE ACCUSED REQUIRES REPRESENTATION OF THE ACCUSED BY**
17 **AN ATTORNEY.**

4 **(I) REDUCE AND DISCOURAGE THE COMMISSION OF CRIME;**

5 **(II) REHABILITATE AND CORRECT INDIVIDUALS CHARGED**
6 **AND CONVICTED OF CRIME;**

7 **(III) ADMINISTER CRIMINAL JUSTICE; AND**

8 **(IV) ADMINISTER AND CONDUCT THE OFFICE; AND**

11 **(3) IN ALL OTHER CASES OF REIMBURSEMENT FOR SERVICES**
12 **RENDERED, COLLECTION SHALL BE MADE IN ACCORDANCE WITH SUBSECTION**
13 **(B) OF THIS SECTION.**

14 **(D) REIMBURSEMENT IN CIVIL AND JUVENILE CASES.**

15 **(1) A COURT EXERCISING OTHER THAN CRIMINAL JURISDICTION**
16 **SHALL ORDER AN INDIGENT INDIVIDUAL REPRESENTED BY THE PUBLIC**

18 PROPERTY FOR 10 YEARS FROM THE DATE OF FILING OR DOCKETING UNLESS
19 THE LIEN IS DISCHARGED SOONER; AND

20 (II) HAVE THE FORCE AND EFFECT OF A JUDGMENT AT LAW.

21 (3) (I) THE CLERKS OF THE CIRCUIT COURTS AND THE
22 DISTRICT COURT SHALL PROVIDE SEPARATE BOOKS TO RECORD LIENS UNDER
23 THIS SECTION.

24 (II) THE BOOKS SHALL BE PROPERLY INDEXED IN THE
25 NAME OF THE DEBTOR.

26 (III) THE PUBLIC DEFENDER MAY NOT BE REQUIRED TO PAY

29 **GENERAL REVISOR'S NOTE TO SUBTITLE:**

30 Former Art. 27A, § 14, which provided for local exemptions to the provisions of
31 Article 27A, is deleted as obsolete. The Public Defender provides services in all

1 counties within the State, and no county implemented or maintained a separate or
2 different system before September 1, 1971.

3 GENERAL REVISOR'S NOTE TO TITLES 14, 15, AND 16:

4 This revision contains three revised titles of the Criminal Procedure Article.

5 The Department of Legislative Services is charged with revising the law in a
6 clear, concise, and organized manner, without changing the effect of the law. One
7 precept of code revision has been that, once something is said, it should be said in the
8 same way every time. To that end, the Criminal Procedure Article Additions Review
9 Committee conformed the language and organization of Titles 14, 15, and 16 to that of
10 the rest of the Criminal Procedure Article and other previously enacted revised
11 articles to the extent possible.

12 It is the manifest intent both of the General Assembly and the Criminal
13 Procedure Article Additions Review Committee that this bulk revision of the
14 substantive laws regarding the Office of the State Prosecutor, the Office of the State's
15 Attorney, and the Office of the Public Defender render no substantive change. The
16 guiding principle of the preparation of Titles 14, 15, and 16 of the Criminal Procedure
17 Article is that state in *Welch v. Humphrey*, 200 Md. 410, 417 (1952):

18 [T]he principle function of a Code is to reorganize the statutes and state them in
19 simpler form. Consequently any changes made in them by Code are presumed to
20 be for the purpose of clarity rather than change of meaning. Therefore, even a
21 change in the phraseology of a statute by a codification thereof will not
22 ordinarily modify the law, unless the change is so radical and material that the
23 intention of the Legislature to modify the law appears unmistakably from the
24 language of the Code. (citations omitted).

25 Accordingly, except to the extent that changes, which are noted in Revisor's Notes,
26 clarify the former law, the enactment of these Titles 14, 15, and 16 in no way is
27 intended to make any change to the substantive law of Maryland relating to the Office
28 of the State Prosecutor, the Office of the State's Attorney, or the Office of the Public
29 Defender.

30 Throughout Titles 15 and 16, as in other revised articles, the word "regulations"
31 generally is substituted for the former references to "rules and regulations" to
32 distinguish, to the extent possible, between regulations of executive units and rules of
33 judicial or legislative units and to establish consistency in the use of the words. This
34 substitution conforms to the practice of the Division of State Documents.

35 In many provisions in these titles, as in other revised articles, the word "unit" is
36 substituted for former references to governmental entities such as an "agency",
37 "board", or "commission". In revised articles of the Code, the word "unit" is used as the
38 general term for an organization in government because it is broad enough to include
39 all such entities.

1 References to current units and positions are substituted for obsolete references
2 to entities and positions that have been abolished or have otherwise ceased to exist.

3 Also throughout these titles, references to the “chair” of a committee or other
4 unit are substituted for former references to “chairman” in accordance with the style
5 manual of the Office of Policy Analysis of the Department of Legislative Services. SG §
6 2–1238(11) requires the Office of Policy Analysis to include in the style manual “a
7 drafting rule that requires, to the extent practicable, the use of words that are neutral
8 as to gender except for a subject matter that specifically applies only to one gender and
9 except for a name or organizational title”.

10 In some instances, the staff of the Department of Legislative Services may
11 create “Special Revisor’s Notes” to reflect the substantive effect of legislation enacted
12 during the 2008 Session on some provisions of these titles.

13 SECTION 3. AND BE IT FURTHER ENACTED, That it is the intention of the
14 General Assembly that, except as expressly provided in this Act, this Act shall be
15 construed as a nonsubstantive revision, and may not otherwise be construed to render
16 any substantive change in the law of the State.

17 SECTION 4. AND BE IT FURTHER ENACTED, That the catchlines, captions,
18 Revisor’s Notes, Special Revisor’s Notes, and General Revisor’s Notes contained in this
19 Act are not law and may not be considered to have been enacted as a part of this Act.

20 SECTION 5. AND BE IT FURTHER ENACTED, That nothing in this Act
21 affects the term of office of an appointed or elected member of any commission, office,
22 department, agency, or other unit. An individual who is a member of a unit on the
23 effective date of this Act shall remain a member for the balance of the term to which
24 appointed or elected, unless the member sooner dies, resigns, or is removed under
25 provisions of law.

26 SECTION 6. AND BE IT FURTHER ENACTED, That, except as expressly
27 provided to the contrary in this Act, any transaction or employment status affected by
28 or flowing from any change of nomenclature or any statute amended, repealed, or
29 transferred by this Act and validly entered into or existing before the effective date of
30 this Act and every right, duty, or interest flowing from a statute amended, repealed, or
31 transferred by this Act remains valid after the effective date of this Act and may be
32 terminated, completed, consummated, or enforced as required or allowed by any
33 statute amended, repealed, or transferred by this Act as though the repeal,
34 amendment, or transfer had not occurred. If a change in nomenclature involves a
35 change in name or designation of any State unit, the successor unit shall be considered
36 in all respects as having the powers and obligations granted the former unit.

37 SECTION 7. AND BE IT FURTHER ENACTED, That the continuity of every
38 commission, office, department, agency, or other unit is retained. The personnel,
39 records, files, furniture, fixtures, and other properties and all appropriations, credits,
40 assets, liabilities, and obligations of each retained unit are continued as the personnel,

1 records, files, furniture, fixtures, properties, appropriations, credits, assets, liabilities,
2 and obligations of the unit under the laws enacted by this Act.

3 SECTION 8. AND BE IT FURTHER ENACTED, That, except as expressly
4 provided to the contrary in this Act, any person licensed, registered, certified, or issued
5 a permit or certificate by any commission, office, department, agency, or other unit
6 established or continued by any statute amended, repealed, or transferred by this Act
7 is considered for all purposes to be licensed, registered, certified, or issued a permit or
8 certificate by the appropriate unit continued under this Act for the duration of the
9 term for which the license, registration, certification, or permit was issued, and may
10 renew that authorization in accordance with the appropriate renewal provisions of this
11 Act.

12 SECTION 9. AND BE IT FURTHER ENACTED, That this Act does not
13 rescind, supersede, change, or modify any rule adopted by the Court of Appeals that is
14 or was in effect on the effective date of this Act concerning the practice and procedure
15 in and the administration of the appellate courts and the other courts of this State.

16 SECTION 10. AND BE IT FURTHER ENACTED, That the publisher of the
17 Annotated Code of Maryland, in consultation with and subject to the approval of the
18 Department of Legislative Services, shall correct, with no further action required by
19 the General Assembly, cross-references and terminology rendered incorrect by this
20 Act or by any other Act of the General Assembly of 2008 that affects provisions
21 enacted by this Act. The publisher shall adequately describe any such correction in an
22 editor's note following the section affected.

23 SECTION 11. AND BE IT FURTHER ENACTED, That this Act shall take
24 effect October 1, 2008.
