1 AN ACT concerning

Maryland Higher Education Commission – Review of Duplicative Academic Programs

4 FOR the purpose of requiring the Maryland Higher Education Commission to make 5 certain determinations concerning certain programs approved or implemented during or after certain dates under certain circumstances; requiring the 6 7 Commission to include certain findings as part of certain determinations; 8 authorizing the Commission to take certain actions as a result of certain 9 determinations; providing that certain decisions of the Commission concerning 10 certain duplication of academic programs are subject to judicial review in the circuit court in accordance with certain rules and certain provisions of the 11 Administrative Procedure Act; providing that this Act shall be construed to 12 13 require the Commission to review certain determinations regarding certain duplication of academic programs; requiring Morgan State University or the 14 University of Baltimore to accept certain students enrolled in a certain program 15at Towson University that has been discontinued under a certain order of the 16 Commission or a court; and generally relating to the review of duplicative 17 academic programs. 18
