A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Baltimore City – Peale**
3 **Museum**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to extend the deadline by which the Board of Trustees of the Baltimore City
6 Historical Society, Inc. may present evidence to the Board of Public Works that
7 a matching fund will be provided; and generally relating to the Maryland
8 Consolidated Capital Bond Loan of 2006 and the Board of Trustees of the
9 Baltimore City Historical Society.

10 BY repealing and reenacting, with amendments,
11 Chapter 46 of the Acts of the General Assembly of 2006
12 Section 1(3) Item ZA01(AC) and ZA02(AC)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:
