## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Uniform Interstate Depositions and Discovery Act**

3 FOR the purpose of enacting the Maryland Uniform Interstate Depositions and  
4 Discovery Act; establishing procedures for requesting and issuing certain  
5 subpoenas; providing for the service of certain subpoenas; establishing that  
6 certain Maryland Rules apply to certain subpoenas; requiring that an  
7 application for a protective order or to enforce, quash, or modify certain  
8 subpoenas comply with certain rules and statutes and be filed in a certain court;  
9 requiring certain consideration to be given in applying and construing this Act;  
10 defining certain terms; repealing existing provisions of law relating to foreign  
11 depositions; providing for the application of this Act; and generally relating to  
12 interstate depositions and discovery.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
25 MARYLAND, That Section(s) 9–401 through 9–403 and the subtitle “Subtitle 4.  
26 Foreign Depositions” of Article – Courts and Judicial Proceedings of the Annotated  
27 Code of Maryland be repealed.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
2 read as follows:

3 **Article – Courts and Judicial Proceedings**

4 **SUBTITLE 4. MARYLAND UNIFORM INTERSTATE DEPOSITIONS AND DISCOVERY**  
5 **ACT.**

6 **9-401.**

7 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
8 INDICATED.

9 (B) “FOREIGN JURISDICTION” MEANS A STATE OTHER THAN THIS  
10 STATE.

11 (C) “FOREIGN SUBPOENA” MEANS A SUBPOENA ISSUED UNDER  
12 AUTHORITY OF A COURT OF RECORD OF A FOREIGN JURISDICTION.

13 (D) “PERSON” MEANS AN INDIVIDUAL, CORPORATION, BUSINESS  
14 TRUST, ESTATE, TRUST, PARTNERSHIP, LIMITED LIABILITY COMPANY,  
15 ASSOCIATION, JOINT VENTURE, PUBLIC CORPORATION, GOVERNMENT,  
16 GOVERNMENTAL SUBDIVISION, AGENCY, OR INSTRUMENTALITY, OR ANY OTHER  
17 LEGAL OR COMMERCIAL ENTITY.

18 (E) “STATE” MEANS A STATE OF THE UNITED STATES, THE DISTRICT  
19 OF COLUMBIA, PUERTO RICO, THE UNITED STATES VIRGIN ISLANDS, OR ANY  
20 TERRITORY OR INSULAR POSSESSION SUBJECT TO THE JURISDICTION OF THE  
21 UNITED STATES.

22 (F) “SUBPOENA” MEANS A DOCUMENT, HOWEVER DENOMINATED,  
23 ISSUED UNDER AUTHORITY OF A COURT OF RECORD REQUIRING A PERSON TO:

24 (1) ATTEND AND GIVE TESTIMONY AT A DEPOSITION;

25 (2) PRODUCE AND PERMIT INSPECTION AND COPYING OF  
26 DESIGNATED BOOKS, DOCUMENTS, RECORDS, ELECTRONICALLY STORED  
27 INFORMATION, OR TANGIBLE THINGS IN THE POSSESSION, CUSTODY, OR  
28 CONTROL OF THE PERSON; OR

29 (3) PERMIT INSPECTION OF PREMISES UNDER THE CONTROL OF  
30 THE PERSON.

31 **9-402.**

1           (A) (1) TO REQUEST ISSUANCE OF A SUBPOENA UNDER THIS  
2 SECTION, A PARTY SHALL SUBMIT A FOREIGN SUBPOENA TO A CLERK OF THE  
3 CIRCUIT COURT FOR THE COUNTY IN WHICH DISCOVERY IS SOUGHT TO BE  
4 CONDUCTED IN THIS STATE.

5           (2) A REQUEST FOR THE ISSUANCE OF A SUBPOENA UNDER THIS  
6 SUBTITLE DOES NOT CONSTITUTE AN APPEARANCE IN THE COURTS OF THIS  
7 STATE.

8           (B) WHEN A PARTY SUBMITS A FOREIGN SUBPOENA TO A CLERK OF  
9 COURT IN THIS STATE, THE CLERK, IN ACCORDANCE WITH THAT COURT'S  
10 PROCEDURE, SHALL PROMPTLY ISSUE A SUBPOENA FOR SERVICE UPON THE  
11 PERSON TO WHICH THE FOREIGN SUBPOENA IS DIRECTED.

12           (C) A SUBPOENA UNDER SUBSECTION (B) OF THIS SECTION SHALL:

13           (1) INCORPORATE THE TERMS USED IN THE FOREIGN SUBPOENA;  
14 AND

15           (2) CONTAIN OR BE ACCOMPANIED BY THE NAMES, ADDRESSES,  
16 AND TELEPHONE NUMBERS OF ALL COUNSEL OF RECORD IN THE PROCEEDING  
17 TO WHICH THE SUBPOENA RELATES AND OF ANY PARTY NOT REPRESENTED BY  
18 COUNSEL.

19 **9-403.**

20           A SUBPOENA ISSUED BY A CLERK OF COURT UNDER § 9-402 OF THIS  
21 SUBTITLE SHALL BE SERVED IN COMPLIANCE WITH MARYLAND RULE 2-510.

22 **9-404.**

23           TITLE 2, CHAPTER 400 OF THE MARYLAND RULES AND MARYLAND RULE  
24 2-510 APPLY TO SUBPOENAS ISSUED UNDER § 9-402 OF THIS SUBTITLE.

25 **9-405.**

26           AN APPLICATION TO THE COURT FOR A PROTECTIVE ORDER OR TO  
27 ENFORCE, QUASH, OR MODIFY A SUBPOENA ISSUED BY A CLERK OF COURT  
28 UNDER § 9-402 OF THIS SUBTITLE SHALL COMPLY WITH THE RULES AND  
29 STATUTES OF THIS STATE AND BE SUBMITTED TO THE CIRCUIT COURT FOR THE  
30 COUNTY IN WHICH DISCOVERY IS TO BE CONDUCTED.

31 **9-406.**

1           **IN APPLYING AND CONSTRUING THIS UNIFORM ACT, CONSIDERATION**  
2 **SHALL BE GIVEN TO THE NEED TO PROMOTE UNIFORMITY OF THE LAW WITH**  
3 **RESPECT TO ITS SUBJECT MATTER AMONG STATES THAT ENACT IT.**

4 **9-407.**

5           **THIS SUBTITLE MAY BE CITED AS THE MARYLAND UNIFORM INTERSTATE**  
6 **DEPOSITIONS AND DISCOVERY ACT.**

7           SECTION 3. AND BE IT FURTHER ENACTED, That this Act applies to  
8 requests for discovery in cases pending on the effective date of this Act.

9           SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect  
10 October 1, 2008.
