## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – State’s Attorney – Salary**

3 FOR the purpose of clarifying the salary of the State’s Attorney for Baltimore County;  
4 providing that the salary be increased annually by a certain amount; and  
5 generally relating to the State’s Attorney for Baltimore County.

6 BY repealing and reenacting, without amendments,

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Criminal Procedure**

23 15–404.

24 (a) This section applies only in Baltimore County.

1           (b) Subject to Article III, § 35 of the Maryland Constitution[, and beginning  
2 with the term of the State's Attorney who was elected to that position in 1982, the  
3 State's Attorney's salary]:

4                   [(1) is equal to the salary of a circuit court judge; and

5                   (2) shall be increased 5% each year during the State's Attorney's term  
6 of office]

7                   **(1) BEGINNING ON JANUARY 2, 2008, THE SALARY OF THE**  
8 **STATE'S ATTORNEY IS \$194,276; AND**

9                   **(2) IN EACH YEAR THEREAFTER, THE SALARY SHALL BE**  
10 **INCREASED BY THE SAME ANNUAL COST OF LIVING INCREASE RECEIVED BY**  
11 **BALTIMORE COUNTY EMPLOYEES.**

12           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 July 1, 2008.
