3 **Place of Business**

4 FOR the purpose of specifying that, in an appeal from a decision of the Board of
5 License Commissioners of Prince George's County ~~does~~, the court may not stay
6 an order of the Board to close a place of business that is licensed to sell alcoholic
7 beverages; and generally relating to the Board of License Commissioners of
8 Prince George's County.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
20 MARYLAND, That the Laws of Maryland read as follows:

21 **Article 2B – Alcoholic Beverages**

2 (a) The decision of a local licensing board, in approving, suspending,
3 revoking and restricting, or refusing to approve, suspend, revoke or restrict a license,
4 or a licensee, shall be subject to appeal in the manner provided in this section.

5 (b) (4) (I) **THIS PARAGRAPH APPLIES ONLY IN PRINCE GEORGE’S**
6 **COUNTY.**

7 (II) [In Prince George’s County, the] **THE** governing body of the
8 municipality in which the licensed place of business is located or proposed to be
9 located may appeal therefrom to the circuit court of the county upon payment of all
10 costs incident to the hearing before the Board of License Commissioners.

11 (III) ~~**AN IN AN APPEAL FROM A DECISION OF THE BOARD OF**~~
12 ~~**LICENSE COMMISSIONERS DOES, THE COURT MAY NOT STAY AN ORDER OF THE**~~
13 ~~**BOARD TO CLOSE A LICENSED PLACE OF BUSINESS.**~~

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 June 1, 2008.
