Election Law - Qualification of Voters - Proof of Identity

3 FOR the purpose of requiring an election judge to establish certain information with 4 regard to certain voters; requiring an election judge to qualify a voter by 5 requesting the voter to present a certain form of identification; requiring an 6 election judge to authorize an individual to vote a regular ballot under certain 7 circumstances; allowing a voter who is unable to present a certain form of 8 identification to vote by provisional ballot under certain circumstances; 9 prohibiting a person from voting or attempting to vote under a false form of identification; requiring the Motor Vehicle Administration to issue an 10 11 identification card to certain voters at no charge; and generally relating to proof of identity of voters. 12
