- 3 FOR the purpose of making it a misdemeanor for a person knowingly and willfully to 4 furnish an alcoholic beverage for consumption to an individual under the age of 5 21 years under certain circumstances; imposing a certain criminal penalty; 6 repealing certain provisions requiring the issuance of a civil citation to a person 7 who violates the prohibition against furnishing an alcoholic beverage for 8 consumption to an underage individual; clarifying the elements of a certain 9 alcoholic beverage violation; and generally relating to penalties for furnishing 10 an alcoholic beverage to an underage individual.
