- (xvii) who was a member of the Department of Public Safety and Correctional Services Internal Investigative Unit who has powers granted to a police officer under § 10–701 of the Correctional Services Article on June 30, 2007, and who elects membership on or before December 31, 2007; OR

1	(XVIII) WHO WAS EMPLOYED ON JULY 1, 2008, AS A POLICE
2	OFFICER BY THE BALTIMORE CITY COMMUNITY COLLEGE POLICE FORCE AND

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 July 1, 2008.
