1 AN ACT concerning

2 **Reorganization of State Government - Department of Information**  
3 **Technology**

4 FOR the purpose of reorganizing State government by establishing a Department of  
5 Information Technology as a principal unit of the Executive Branch; providing  
6 for the qualifications, appointment, powers, duties, and salary of the Secretary  
7 of Information Technology; providing for the duties of the Department of  
8 Information Technology; specifying that the Department of Information  
9 Technology is responsible for administering the information technology  
10 functions of the Executive Branch of State government; transferring the  
11 information technology and telecommunications functions of the Executive  
12 Branch from the Department of Budget and Management to the Department of  
13 Information Technology; requiring the Secretary to provide a certain annual  
14 report on certain technology development projects to the Department of  
15 Legislative Services; transferring the Telecommunications Access of Maryland

11          (A) **THE HEAD OF THE DEPARTMENT IS THE SECRETARY OF**  
12 **INFORMATION TECHNOLOGY, WHO SHALL BE APPOINTED BY THE GOVERNOR**  
13 **WITH THE ADVICE AND CONSENT OF THE SENATE.**

14          (B) **THE SECRETARY SHALL HAVE EXPERIENCE IN INFORMATION**  
15 **TECHNOLOGY, DATA PROCESSING, TELECOMMUNICATIONS, AND SYSTEMS**  
16 **PROCUREMENT, PLANNING, AND MANAGEMENT.**

17          (C) **BEFORE TAKING OFFICE, THE APPOINTEE SHALL TAKE THE OATH**

19          (D) **THE SECRETARY SHALL ADVISE THE GOVERNOR ON ALL MATTERS**

21 **GOVERNOR’S POLICIES ON THOSE MATTERS.**

22          (E) **THE SECRETARY IS RESPONSIBLE FOR THE OPERATION OF THE**

25 **DEPARTMENT.**

18 **EXCEEDS \$1,000,000;**

20 **BUSINESS FUNCTION ASSOCIATED WITH THE PUBLIC HEALTH, EDUCATION,**  
21 **SAFETY, OR FINANCIAL WELL-BEING OF THE CITIZENS OF MARYLAND; OR**

22                   **(3) THE SECRETARY DETERMINES THAT THE PROJECT REQUIRES**  
23 **THE SPECIAL ATTENTION AND CONSIDERATION GIVEN TO A MAJOR**

3           (H) “NONVISUAL ACCESS” MEANS THE ABILITY, THROUGH KEYBOARD  
4 CONTROL, SYNTHESIZED SPEECH, BRAILLE, OR OTHER METHODS NOT  
5 REQUIRING SIGHT TO RECEIVE, USE, AND MANIPULATE INFORMATION AND  
6 OPERATE CONTROLS NECESSARY TO ACCESS INFORMATION TECHNOLOGY.

7           (I) “RESOURCE SHARING” MEANS THE UTILIZATION OF A STATE  
8 RESOURCE BY PRIVATE INDUSTRY IN EXCHANGE FOR THE PROVISION TO THE  
9 STATE OF A COMMUNICATION SERVICE OR OTHER CONSIDERATION.
