A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Prince George’s**
3 **County – Ernest Everett Just Monument**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007
5 to alter a requirement that the Board of Directors of The Ernest Everett Just
6 Foundation, Inc. provide a certain matching fund; and generally relating to the
7 Maryland Consolidated Capital Bond Loan of 2007 and the Ernest Everett Just
8 Monument.

9 BY repealing and reenacting, with amendments,
10 Chapter 488 of the Acts of the General Assembly of 2007
11 Section 1(3) Item ZA01(AV) and Item ZA02(BL)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:
