A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws - Rules of the Road - Malfunctioning Traffic Control Signals**

3 FOR the purpose of requiring a driver who is approaching a traffic control signal with
4 no visible lighted indication to reduce speed and prepare to yield to other
5 vehicles in or approaching the intersection; clarifying that a driver shall obey a
6 stop sign in certain circumstances; clarifying a certain term; and generally
7 relating to malfunctioning traffic control signals.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article - Transportation**

21 21-202.

22 **(M) IF NO LIGHTED INDICATION IS VISIBLE TO A DRIVER APPROACHING**
23 **A TRAFFIC CONTROL SIGNAL, THE DRIVER SHALL REDUCE SPEED AND PREPARE**
24 **TO YIELD TO OTHER VEHICLES IN OR APPROACHING THE INTERSECTION.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 [(m)] (N) Except for those provisions of this section that by their very nature
2 cannot apply, this section applies to a traffic control signal placed at a location other
3 than an intersection. Each stop required by the signal shall be made at a sign or
4 marking on the pavement indicating where the stop shall be made or, if there is no
5 sign or marking, at the signal.

7 (a) If a flashing red or yellow light is used in a traffic **CONTROL** signal or
8 with a traffic sign, it requires obedience by vehicular traffic as provided in this section.

9 (G) (1) **IF NO LIGHTED INDICATION IS VISIBLE TO A DRIVER**
10 **APPROACHING A TRAFFIC CONTROL SIGNAL THAT NORMALLY USES A FLASHING**
11 **LIGHT, THE DRIVER SHALL REDUCE SPEED AND PREPARE TO YIELD TO OTHER**
12 **VEHICLES IN OR APPROACHING THE INTERSECTION.**

13 (2) **IF FACING A STOP SIGN, THE APPROACHING DRIVER SHALL**
14 **OBEY THE STOP SIGN.**

15 [(g)] (H) This section does not apply at any railroad grade crossing.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2008.
