- 10 (d) (1) Each quarter of the fiscal year the Board of Trustees shall 11 estimate[:
- 12 (i) one-fourth of an amount, not exceeding 1.2% of the market 13 value as of the last day of the preceding quarter of assets externally invested in real 14 estate or alternative investments, necessary for external real estate or alternative 15 investment management services; and
- 16 (ii)] one-fourth of an amount, not exceeding 0.3% of the market 17 value as of the last day of the preceding quarter of invested assets that are externally 18 managed exclusive of assets invested in real estate or alternative investments, 19 necessary to procure and retain investment management services other than external 20 real estate or alternative investment management services.
  - [(2) In addition to the amount estimated in paragraph (1)(i) of this subsection, any previously estimated amount that has not been paid to an external real estate or alternative investment management service by the last day of each quarter shall be carried over into the next quarter and added to the new estimate.]
