State Retirement and Pension Systems - Investments

FOR the purpose of repealing certain restrictions placed on the Board of Trustees for 3 the State Retirement and Pension System with regard to investing the assets of 4 5 the several systems of the State Retirement and Pension System; repealing the 6 requirement that the Board of Public Works approve certain sales and 7 purchases of real estate by the Board of Trustees; requiring the Comptroller, 8 Treasurer, and Secretary of Budget and Management to approve certain sales 9 and purchases of real estate by the Board of Trustees; requiring the Board of Trustees to submit certain reports by certain dates; clarifying that certain 10 provisions of the State Finance and Procurement Article do not apply to certain 11 transactions of the Board of Trustees; eliminating certain limitations on certain 12 fees paid by the Board of Trustees to certain investment managers; clarifying 13 that the Board of Trustees is not subject to any limitation on certain fees paid to 14 certain investment managers; and generally relating to the investments of the 15 State Retirement and Pension System. 16

- 14 (d) (1) Each quarter of the fiscal year the Board of Trustees shall 15 estimate[:
- 16 (i) one-fourth of an amount, not exceeding 1.2% of the market 17 value as of the last day of the preceding quarter of assets externally invested in real 18 estate or alternative investments, necessary for external real estate or alternative 19 investment management services; and
 - (ii)] one-fourth of an amount, not exceeding 0.3% of the market value as of the last day of the preceding quarter of invested assets that are externally managed exclusive of assets invested in real estate or alternative investments, necessary to procure and retain investment management services other than external real estate or alternative investment management services.
 - [(2) In addition to the amount estimated in paragraph (1)(i) of this subsection, any previously estimated amount that has not been paid to an external real estate or alternative investment management service by the last day of each quarter shall be carried over into the next quarter and added to the new estimate.]
