1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2 MARYLAND, That the Laws of Maryland read as follows:

3 Article - Family Law

4 4-506.

- 5 (d) The final protective order may include any or all of the following relief:
- 6 (1) order the respondent to refrain from abusing or threatening to abuse any person eligible for relief;
- 8 (2) order the respondent to refrain from contacting, attempting to contact, or harassing any person eligible for relief;
 - (3) order the respondent to refrain from entering the residence of any person eligible for relief;
 - (4) where the person eligible for relief and the respondent are residing together at the time of the abuse, order the respondent to vacate the home immediately and award temporary use and possession of the home to the person eligible for relief or, in the case of alleged abuse of a child or alleged abuse of a vulnerable adult, award temporary use and possession of the home to an adult living in the home, provided that the court may not grant an order to vacate and award temporary use and possession of the home to a nonspouse person eligible for relief unless the name of the person eligible for relief appears on the lease or deed to the home or the person eligible for relief has shared the home with the respondent for a period of at least 90 days within 1 year before the filing of the petition;
 - (5) order the respondent to remain away from the place of employment, school, or temporary residence of a person eligible for relief or home of other family members;
- 25 (6) order the respondent to remain away from a child care provider of a person eligible for relief while a child of the person is in the care of the child care provider;
 - (7) award temporary custody of a minor child of the respondent and a person eligible for relief;
 - (8) establish temporary visitation with a minor child of the respondent and a person eligible for relief on a basis which gives primary consideration to the welfare of the minor child and the safety of any other person eligible for relief. If the court finds that the safety of a person eligible for relief will be jeopardized by unsupervised or unrestricted visitation, the court shall condition or restrict visitation as to time, place, duration, or supervision, or deny visitation entirely, as needed to guard the safety of any person eligible for relief;

- 1 award emergency family maintenance as necessary to support any 2 person eligible for relief to whom the respondent has a duty of support under this article, including an immediate and continuing withholding order on all earnings of 3 the respondent in the amount of the ordered emergency family maintenance in 4 5 accordance with the procedures specified in Title 10, Subtitle 1, Part III of this article; 6 award temporary use and possession of a vehicle jointly owned by 7 the respondent and a person eligible for relief to the person eligible for relief if necessary for the employment of the person eligible for relief or for the care of a minor 8 9 child of the respondent or a person eligible for relief; 10 direct the respondent or any or all of the persons eligible for relief (11)11 to participate in professionally supervised counseling or a domestic violence program; 12 order the respondent to surrender to law enforcement authorities 13 any firearm in the respondent's possession for the duration of the protective order; or 14 (13) order the respondent to pay filing fees and costs of a proceeding under this subtitle. 15 16 (E) IF THE JUDGE AWARDS TEMPORARY CUSTODY OF A MINOR CHILD 17 UNDER SUBSECTION (D)(7) OF THIS SECTION, THE JUDGE MAY ORDER A LAW 18 ENFORCEMENT OFFICER TO USE ALL REASONABLE AND NECESSARY FORCE TO 19 RETURN THE MINOR CHILD TO THE CUSTODIAL PARENT AT THE TIME OF 20 SERVICE OR AS SOON AS POSSIBLE AFTER ENTRY OF THE FINAL PROTECTIVE 21 ORDER. 22 [(e)] (F) In determining whether to order the respondent to vacate the 23 home under § 4-505(a)(2)(iv) of this subtitle or subsection (d)(4) of this section, the judge shall consider the following factors: 24 25the housing needs of any minor child living in the home; (1) 26 the duration of the relationship between the respondent and any (2)person eligible for relief; 27 28 (3)title to the home; 29 (4) pendency and type of criminal charges against the respondent; 30 the history and severity of abuse in the relationship between the (5)respondent and any person eligible for relief; 31
 - (6) the existence of alternative housing for the respondent and any person eligible for relief; and

3 4 5 6 7	[(f)] (G) (1) A copy of the final protective order shall be served on the petitioner, the respondent, any affected person eligible for relief, the appropriate law enforcement agency, and any other person the judge determines is appropriate, in open court or, if the person is not present at the final protective order hearing, by first-class mail to the person's last known address.
8 9 10 11	(2) A copy of the final protective order served on the respondent in accordance with paragraph (1) of this subsection constitutes actual notice to the respondent of the contents of the final protective order. Service is complete upon mailing.
12 13 14	[(g)] (H) (1) Except as provided in paragraph (2) of this subsection, all relief granted in a final protective order shall be effective for the period stated in the order, not to exceed 12 months.
15 16 17	(2) A subsequent circuit court order pertaining to any of the provisions included in the final protective order shall supersede those provisions in the final protective order.

19 20	(a) (1) A protective order may be modified or rescinded during the term of the protective order after:
21 22	(i) giving notice to all affected persons eligible for relief and the respondent; and
23	(ii) a hearing.
24 25 26	(2) For good cause shown, a judge may extend the term of the protective order for 6 months beyond the period specified in [\S 4–506(g)] \S 4–506(H) of this subtitle, after:
27 28	(i) giving notice to all affected persons eligible for relief and the respondent; and

30 31	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
