Public Health – Ephedrine, Pseudoephedrine, or Phenylpropanolamine Purchases – Statewide Electronic Logbook

4 FOR the purpose of requiring the Alcohol and Drug Abuse Administration to assist in 5 the regulation of the sale of ephedrine. pseudoephedrine, or 6 phenylpropanolamine by establishing and maintaining a real-time statewide 7 electronic logbook for the purpose of allowing pharmacies and retailers to enter 8 into the logbook any transaction required to be reported by statute relating to 9 the sale of ephedrine, pseudoephedrine, or phenylpropanolamine; requiring the 10 Administration to adopt regulations requiring pharmacies and retailers to 11 maintain electronic logs of certain ephedrine, pseudoephedrine, or purchases, enter certain information about certain 12 phenylpropanolamine purchases into the statewide electronic logbook, and require a person 13 14 purchasing, receiving, or otherwise acquiring ephedrine, pseudoephedrine, or 15phenylpropanolamine to produce certain proof of identity and sign the electronic 16 log or a receipt that documents the date of the transaction, the name of the 17and the quantity of ephedrine, pseudoephedrine, person, or 18 phenylpropanolamine purchased, received, or otherwise acquired; requiring the 19 Administration to provide pharmacies and retailers in the State access to the 20electronic logbook for the purpose of entering transaction information required 21to be reported by statute and certain technical assistance; providing that the 22electronic logbook has the capability to calculate both State and federal 23ephedrine, pseudoephedrine, or phenylpropanolamine purchase limitations; 24providing that information entered into the electronic logbook is confidential and is not subject to the Freedom of Information Act; requiring the 2526 Administration to provide access to the real-time electronic logbook to certain 27persons and law enforcement officials; authorizing the Administration to 28destroy certain transaction records maintained in the real-time electronic 29logbook within a certain date from the date of entry unless the transaction 30 record is being used in an ongoing criminal investigation or criminal proceeding; 31prohibiting a pharmacy or retailer from selling ephedrine, pseudoephedrine, or
