CHAPTER _____

1 AN ACT concerning

2 **Courts – Jury Trials in Civil Actions – Amount in Controversy**

3 FOR the purpose of altering the amount in controversy in a civil action in which a
4 party may not demand a jury trial; providing for the construction and
5 application of this Act; making this Act contingent on the passage and
6 ratification of a certain constitutional amendment; and generally relating to
7 jury trials in civil actions.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Courts and Judicial Proceedings**

16 4–402.

17 (e) (1) In a civil action in which the amount in controversy does not
18 exceed [\$10,000] ~~\$20,000~~ **\$15,000**, exclusive of attorney's fees if attorney's fees are
19 recoverable by law or contract, a party may not demand a jury trial pursuant to the
20 Maryland Rules.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be
2 construed to affect any requirement under Maryland Rule 2-325 for withdrawal of an
3 election for jury trial after a party files a demand electing a trial by jury.

4 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be
5 construed to apply only prospectively and may not be applied or interpreted to have
6 any effect on or application to any civil action filed before the effective date of this Act.

7 SECTION 4. AND BE IT FURTHER ENACTED, That this Act is contingent on
8 the passage of Chapter ___ (S.B.___/H.B.___) (8lr2104) of the Acts of the General
9 Assembly of 2008, a constitutional amendment, and its ratification by the voters of the
10 State.

11 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions
12 of Section 4 of this Act, this Act shall take effect on the proclamation of the Governor
13 that the constitutional amendment, having received a majority of the votes cast at the
14 general election, has been adopted by the people of Maryland.
