Pharmacy Permit Holders – Signs for Reporting Incorrectly Filled Prescriptions

- FOR the purpose of requiring pharmacy permit holders to post certain signs that inform consumers about how to report incorrectly filled prescriptions; requiring that certain signs be in a certain font include certain information regarding the process for resolving incorrectly filled prescriptions in accordance with certain regulations; requiring that certain signs be positioned and readable at certain points where certain drugs are dispensed to consumers; and generally relating to pharmacy permit holders and signs.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 22 MARYLAND, That the Laws of Maryland read as follows:

3 4	(b) Except as otherwise provided in this section, a pharmacy for which a pharmacy permit has been issued under this title:
5 6 7	(18) (i) May maintain a record log of any prescription that is requested to be filled or refilled by a patient in accordance with the provisions of Title 4, Subtitle 3 of the Health – General Article;
8 9	(ii) If the prescription record of a patient includes the patient's Social Security number, shall keep the Social Security number confidential;
10 11 12	(iii) May not list in the record log the type of illness, disability, or condition that is the basis of any dispensing or distribution of a drug by a pharmacist; and
13 14 15	(iv) May not list a patient's Social Security number, illness, disability, or condition, or the name and type of drug received in the record log if the log is available to other pharmacy customers; [and]
16 17	(19) May not allow an unauthorized individual to represent that the individual is a pharmacist or registered pharmacy technician[.]; AND
