## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Vehicular Crossings – Use by Pedestrians and Bicycles – Authorization**

3 FOR the purpose of authorizing the use of certain vehicular crossings under the  
4 jurisdiction of the Maryland Transportation Authority by pedestrians and  
5 bicycles when authorized by the Chairman of the Maryland Transportation  
6 Authority; and generally relating to the use of vehicular crossings.

7 BY repealing and reenacting, without amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Transportation**

20 21–1401.

1 (a) In this subtitle the following words have the meanings indicated.

2 (b) "Approach" means any roadway, overhead structure, ramp, bridge,  
3 causeway, entrance, and exit provided as a means of access to or departure from a  
4 vehicular crossing.

5 (c) "Bridge" means any bridge within the jurisdiction of the Maryland  
6 Transportation Authority.

7 (d) "Tunnel" means:

8 (1) The Baltimore Harbor Tunnel; and

9 (2) Any other tunnel within the jurisdiction of the Maryland  
10 Transportation Authority.

11 (e) "Vehicular crossing" means:

12 (1) Each tunnel and bridge within the jurisdiction of the Maryland  
13 Transportation Authority; and

14 (2) Each approach to these tunnels and bridges.

15 21-1405.

16 (a) [Pedestrians] **UNLESS AUTHORIZED BY THE CHAIRMAN OF THE**  
17 **MARYLAND TRANSPORTATION AUTHORITY, PEDESTRIANS** may not use any  
18 vehicular crossing.

19 (b) [Bicycles] **UNLESS AUTHORIZED BY THE CHAIRMAN OF THE**  
20 **MARYLAND TRANSPORTATION AUTHORITY, BICYCLES** may not use any vehicular  
21 crossing.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23 October 1, 2008.
